#### NEW SAFETY HOUSE FOR GREEN RIVER

The Green River Firefighters Association has taken delivery of a new mobile Safety House. The fund raising for the Safety House was a long term project, with the new unit being delivered almost three years to the day from the initiation of the project. The Safety House is a 29' unit produced by Surrey.

The Green River Firefighters Association is an organization of 69 fire departments

serving eight counties.

The Safety House will be used to teach more than just fire safety, as the Association begins to teach safety from all hazards. This follows the lead of the Kentucky Firefighters Association with the Risk Watch Program, which addresses all hazards.

Severe Weather is a major concern in Western Kentucky, from storms with heavy lighting to tornadoes. The new Safety House has a Storm Awareness package that uses a sound system, strobe lights, and other resources to simulate different types of storm events.

The new house is a single level unit which will allow safety education to be delivered to adults as well as children. This allows the Association to address the USFA priorities of both children under 14 and adults over 65. The single level still has the same components of the traditional two level, including kitchen, living room and bedroom.

The Safety House cost just under \$35,000. The Association received a 2002 USFA Fire Prevention Grant award in the amount of \$20,000 and raised the additional \$15,000 through donations.

The Association will continue to operate their original Safety House, which was purchased in 1998. This unit has been highly successful and continues to be on the road on a weekly basis. Having two units will allow the Association to better serve the 69 member fire departments and the communities they serve.

Both the existing and new Safety Houses will be stationed at the Area 3 Training Center in Calhoun. The State Fire Rescue Training Staff coordinates scheduling of the Safety Houses. Robin Long places her magic touch on the scheduling process. Training of fire department personnel on the use of both safety houses is a joint effort between Association personnel and Area 3 Fire Rescue Training staff.

As part of the new Safety House being placed in to service, the Green River Association's tow vehicle, a 1984 International truck, has received new paint courtesy of a local auto body collision center. New gold leaf lettering finished out the new look. This truck is funded by the Association and operates side by side with the Area 3 Fire Rescue Training truck. The Green River truck carries a three bottle cascade system which becomes beneficial when it is towing the burn trailer or smoke maze trailer.

Many Association personnel have been involved in the Safety House project. The current officers of the Association include President Harvey Henderson, Daviess County FD; 1st Vice President Robert Cooper, Thruston Philpot FD; 2<sup>nd</sup> Vice President Danny Froehlich, Owensboro FD; Secretary George Caskey, Central City FD; and Treasurer Pat Thompson, Airport Sorgho FD.

#### LETTER TO THE EDITOR

Dear Sir:

### **Fairdealing-Olive fire District**

The Fairdealing-Olive Fire Protection District, Marshall County, has taken delivery of a 2003 Central States Fire Apparatus. The unit is mounted on a Freightliner M-2 chassis with a Detroit Diesel MBE-900, 300 H.P. engine and an Allison EVS 3000 transmission. The M-2 cab is constructed of aluminum.

The body is constructed of stainless steel with roll-up compartment doors. The Hale Q-pac pump is supplied by a 1250 gallon UPF Poly Tank. The rear step compartment is equipped with a 10" dump valve. A 2-1/2" direct tank fill is provided on the rear of the body. A 5000 watt Honda generator powers the two 500 watt flood lights and the body mounted 110 volt plugs.

Body lighting, compartment lighting, FMVSS lighting and warning lights are all Weldon products. This was selected to reduce the inventory of replacement parts. The lower warning light package is Weldon's LED lighting system.

The unit is provided with an Akron deck gun and two (2) 1 3/4" cross lays. This allows the unit to perform a dual role as either a tanker or an attack pumper upon arrival at the scene.

Under the direction of Chief John Smith, Fairdealing Olive covers a diverse area from farm land to high value homes and resorts, in the area of Land between the Lakes region.

#### **Decorated Soldier Hometown Firefighter**

In the picture above, the Campbell County Fire District 1 firefighter stands with his hand on the controls of the engine, and looks back over his shoulder at the camera. But wait! That's not the uniform of District 1 he's wearing, and that sure doesn't look like one of District 1's engines!

That's Staff Sergeant Don Chandler, at the time serving in A Company, 3<sup>rd</sup> Battalion, 7<sup>th</sup> Infantry, U.S. Army, and the engine is one that he and his squad "liberated" from one of Saddam Hussein's palace complexes in Baghdad. In the "Improvise-Adapt-Overcome" spirit of firefighters everywhere, he's using the engine to provide showers for the troops.

Sergeant Chandler started his fire service career in 1987 as a cadet, and later as a firefighter, with the Silver Grove Volunteer Fire Department, which is now part of Campbell County Fire District 1. He later decided to make the U.S. Army his career, and has been serving for 16 years. While serving in the Army, he remains involved in the fire service by joining the local volunteer department wherever he is stationed. Upon his retirement from the Army, he says he intends to pick back up where he left off, serving at the Silver Grove station, where he visited his firefighting colleagues a couple of weeks ago. He was back home on leave for a few days from his base at Ft. Stewart, GA, where he was sent to recuperate from wounds that he received not long after this photo was taken.

On or about April 7, Chandler was wounded in the arm and leg by grenade fragments. This occurred

when Chandler and his squad were sent to block the movement of an Iraqi column moving Southward from Baghdad. During the operation they came under heavy fire.

Chandler's actions during this fire fight earned him the Purple Heart, but also a Bronze Star with a 'V' for valor.

The citation described how Chandler led his squad to block the enemy column, in the process destroying 12 enemy vehicles. "He continued to hold his position and lead his squad throughout the day from an exposed position" reads the award recommendation. In that battle, Sgt. Chandler directed two fire missions using the mortar platoon, and took out at least 20 enemy soldiers who had taken up positions in a building.

Besides his service in the latest Gulf War, Chandler has served in many other hot spots over the years, including the 1991 Gulf War, in Somalia, and in Afghanistan. In a few years he looks forward to participating in firefights of a different kind.

Joe Stambush has been named as one of the three persons who will represent the NVFC to the USFA. They will develop the criteria for selecting departments to receive FEMA Fire Prevention Grants.

Of particular note is the fact that Kentucky departments were granted 3 of the 60 John Deere Gators that were presented by United States Smokeless Tobacco Company (USSTC). USSTC program management told me at the Little Rock meeting that they will offer 75 Gators next year. These units are quite expensive and very well equipped. Ask Charlie Shaw.

Also of note is that the NVFC Board budgeted \$25,000.00 to investigate IRS tax law changes that are necessary to offer a national Length of Service Award Program (LOSAP). Administrative costs negate the advantages of LOSAP programs to local departments. A national program could be very beneficial to them in recruiting and retaining members.

The NVFC is heavily involved in the development of the NFPA EMS Guide (NFPA 450) and the National Highway Transportation Safety Administration (NHTSA) Core Content Group for the 2010 EMS Curriculum. The NFPA EMS Guide is in the final "Comment" period and has been well received to date.

I still chair the NVFC EMS committee and sit on the bylaws, and WMD/Terrorism committees. As a result I am involved in many of the NVFC activities, so, if anyone has any comments or questions regarding the NVFC, I would appreciate a call or correspondence from them.

honestly feel our Risk Watch Program is a success to this point, our county teams and the fire departments throughout all of Kentucky have begun this project with great expectations and much success.



## **Keeping you Up-to-Date**

By the time this paper goes to press the hearing on 401 KAR 63:005 Open Burning will have already taken place (November 26, 2003). I will add the changes you may be interested in below.

I bring this up not to panic anyone because I am not sure if this will harm anyone's training program. I bring this up to remind you that someone will need to step forward and keep you informed about changes in KAR and KRS that effect the fire service. I am on EPA's mailing list so I am made aware of possible changes that will have an impact on the fire service. Smitty and Gerald are both talking about getting out of the business of being your watchdog. Believe me there are those in Frankfort who will eat your lunch in a heartbeat if you don't have someone you trust doing it for you. There are only so many dollars to go around do you want some one else taking the money that should go to the fire service and spending it on roads? Get involved, step out and make sure your part of the Commonwealth does not get left behind.

Section 1 Definitions (3) "Fire Training" means the instruction of industrial, public, and private fire-fighters conducted in accordance with safety standards and procedures as accepted by the Kentucky Fire Commission.

Section 5. Requires that burning debris piles must 2 (a) Have adequate fire lanes to allow access to fire and emergency vehicles and heavy equipment.

Section 8. Procedures for Fire Training. Burning conducted in conjunction with training for public, private and industrial firefighters is subject to the following criteria: (1) All fire training shall be conducted in accordance with safety standards and procedures as accepted by the Kentucky Fire Commission. (2) Any entity intending to conduct fire training shall submitt written notification to the local Division of Air Quality regional office a minimum of 15 days prior to the scheduled training. The written notification shall state the location and date of the proposed fire training, the name and contact information for the on-site training coordinator, the goals and objectives of the training, and a brief summary of what is to be taught. No fire training shall take place without the Division for Air Quality's written approval. (3) Any

materials commonly known to contain asbestos shall not be burned unless the entity conducting the fire training can demonstrate that the materials do not contain asbestos. (4) Materials likely to produce hazardous toxic emissions must be removed prior to the fire training event, to the extent practicable, and properly disposed. (5) Entities conducting fire training shall be limited to one burning event related to training per year for every ten firefighters under their supervision. (6) Between May 1 and September 30, fire training shall not be conducted in any counties, or portions of counties, which are, or were previously, designated moderate nonattainment for ozone, or designated, or previously designated, nonattainment for the 8-hour ozone or PM<sub>2.5</sub> (particulate matter) national ambient air quality standard, pursuant to 401 KAR 51:010. Again I did not provide this information to in any way alarm you but mearly to inform you.

FEMA SPECIAL REVIEW OF FIRE-FIGHTER TRAINING UNCOVERS WAYS TO REDUCE THE RISK OF TRAGIC OUTCOMES

WASHINGTON, D.C. - A technical special report on the risks of firefighting training and ways to reduce deaths and injuries is being released by the Department of Homeland Security's Federal Emergency Management Agency (FEMA) today. The special report underscores the inherent danger of such training but reiterates the importance of experience gained in real, rather than closely controlled training fires.

"It's important that fire departments train firefighters in as close to actual conditions as possible while also protecting them in the process," said Michael D. Brown, Homeland Security Under Secretary for Emergency Preparedness and Response. "This special report highlights how this challenge can be met by the nation's fire service educators and trainers."

The review, compiled by the U.S. Fire Administration (USFA), also highlights the importance of following currently accepted procedures and standards to avoid training deaths and injuries and the need for instructors to avoid situations for which the students are not yet prepared.

The challenge is very real. Since 1987, reported training-related injuries have increased by nearly 21 percent. In 2001 alone, almost 7,000 training-related injuries were reported. That year, a firefighter died and two were injured while participating in a live burn training situation.

At the same time, live fire training buildings and simulators fed by propane or natural gas have many built-in safety features but may not provide the same quality of realism as live fire training in acquired structures. The training buildings, for example, fail to teach students to react to the diverse conditions encountered in real fire operations.

In addition, the need to provide training in situations other than fires, such as hazardous material incidents, increases the danger to participants. In 1997, for example, a member of a unit training to respond to a chemical incident was overcome by a nerve agent and needed to be administered an antidote to stop the seizures.

"Safe and effective - but realistic - firefighter training is vital to meet our mission of preserving life and property," said US Fire Administrator R. David Paulison. "This special report reviews training issues, tragic mistakes of the past and determines ways fire-related training can be safer but effective."

Other lessons learned cited in the special report include:

- It is increasingly important that firefighters receive training in fire behavior and extinguishment methods for different types of buildings;
- Modern protective equipment may make lifethreatening fire conditions less obvious and firefighters must be trained to recognize the visual and physical clues to impending danger;
- During training, a firefighter's physical stress level should be monitored continuously and departments should consider stronger physical screening programs and long-term health and wellness programs to reduce training-related heart attacks and strokes.
- USFA develops technical reports on selected

major incidents, usually involving multiple deaths or a large loss of property. USFA also prepares periodic special reports to discuss events, drills or new technologies or tactics of interest to the fire service. The focus is on "lessons learned" or new knowledge that underscores ongoing issues in fire service. These reports provide detailed information on the nature of the fire problem in this country for policymakers who decide resource allocations, and within the fire service to improve codes and code enforcement, training, public fire education and building technology. This special report was based on meetings, informal interviews and a study of a wide array of fire training literature.

On March 1, 2003, FEMA became part of the U.S. Department of Homeland Security. FEMA's continuing mission within the new department is to lead the effort to prepare the nation for all hazards and effectively manage federal response and recovery efforts following any national incident. FEMA also initiates proactive mitigation activities, trains first responders, and manages Citizen Corps, the National Flood Insurance Program and the U.S. Fire Administration.

#### **IFSAC** Report

I reported in the October issue about our additional levels of accreditation. I have

been getting calls about how the process will work for the new additional levels of certification. We are currently at a basic standstill for issuing additional levels of certification. By the time you read this we will be much closer to issuing the new levels. On December 4th when the Fire Commission meets they will be voting on the new policy manual that will bring all of this new certification process into being. It's kind of like the question which came first the chicken or the egg? I decided to get the process approved by IFSAC first so that if I had to change a policy because of the way they wanted us to do business I would only have to go before the Fire Commission one time instead of going to the commission then to IFSAC and then back to the commission for any final changes.

Beginning in January the testing procedures will be changing. The Fire Commission will be sending out a testing schedule for Haz Mat Awareness & Ops as well as Firefighter I & II in early January. It is the commissions intent to have one test in each area of the state as close to a 12 month schedule as is possible. It may take closer to 15 months to get it all in but the goal is to get each area tested as soon as possible.

The new certifications Airport Firefighter, Fire Instructor, Driver Operator Pumper, and Driver Operator Mobile Water Supply will happen as part of a class. The process will be as follows:

Fire Instructor - A firefighter wanting an international certificate must first meet Kentucky requirements (see Fire Commission Web Site) and complete the new 30 hour Instructional Methodology course and all required skill sheets. The local coordinator schedules a written test. Candidates application, skill sheets, and written test answer sheets, and \$15.00 check made out to KCTCS are sent in for grading and processing. The certificates will take between 2 to 4 weeks to be returned to the individual.

**Driver Operator Pumper/Mobile Water Sup-ply** - A firefighter wanting an international certificate must first meet Kentucky driver requirements and complete the new 12 hour Drivers Training course, complete the take home skill sheet, attend the new 16 hour Pumper Operator course and all required skill sheets. The local coordinator schedules a written test. Candidates application, skill sheets, and written test answer sheets, and \$30.00 check made payable to KCTCS are sent in for grading and processing. The certificates will take between 2 to 4 weeks to be returned to the individual.

**Airport Firefighter** - This program is still in primary development and will require special location to test. If you are interested in this certification contact me at 888-234-7201.

All in all the certification program is moving along nicely. It is our intent for you to become internationally certified at your own pace, locally available, and requiring as little inconvenience to you as is possible. Future plans are for a needs assessment for international Certification for Ariel Apparatus Operator, Fire Officer, Public Fire Educator, Fire Inspector.



# Cooking remains leading cause of home fires, NFPA data show

November 12, 2003 – Year after year, hundreds of people are killed and thousands are injured as a result of one of humankind's most essential and pleasurable activities: cooking. The pursuit of a homecooked meal remains the leading cause of home fires and fire injuries, according to new data from the NFPA (National Fire Protection Association).

As the holidays bring a heightened emphasis on cooking, the NFPA wants to get the word out that people can enjoy a safe holiday — if they stay at the stove while they're preparing hot food. In six out of seven incidents in a study of home cooking fires, ignition occurred while the cook was out of the kitchen.

In 1999, the latest year for which statistics are available, there were 96,200 home structure fires attributed to cooking equipment, including 1,800 fires confined to a cooking vessel. These fires resulted in 331 civilian deaths, 4,183 civilian injuries, and \$511.3 million in direct property damage. Three out of four home cooking fires involve the range. And two-thirds of the time, according to one study, the fires start within the first 15 minutes of cooking.

"Cooking fires remain one of the toughest problems we face," said John R. Hall Jr., Ph.D., of NFPA's Fire Analysis and Research Division. "We have made less headway in preventing cooking fires than in preventing other kinds of home fires."

Home fires have been declining—but those associated with cooking have been declining at a much slower rate. For example, home cooking fires declined by 29 percent from 1980 to 1999, but home fires in general went down by 49 percent. Deaths from home cooking fires declined 21 percent during that period, but total civilian home fire deaths dropped 44 percent. And while injuries from home cooking fires went down 7 percent in those two decades, total civilian home fire injuries fell 19 percent. A study of 45 unattended-cooking fires in New Zealand, done by the New Zealand Fire Service in 1998, showed that distraction and forgetfulness

were the key reasons why devices intended to warm up food ended up starting a fire. About half the time, the study found, the cook was in another room, typically because he or she forgot that something was cooking or was distracted by children, phone calls, visitors, television or other interruptions. In eight fires, the cook was outside the house. In 14 fires, the cook was off the property (in eight cases having forgotten that something was cooking).

People often try to put out cooking fires on their own, and more than half of non-fatal cooking fire injuries occurred while fighting the fire. (That contrasts with total home fires, in which firefighting is involved in only one-third of non-fatal injuries.) With cooking fires, the safest response is not what may first come to mind. Using a fire extinguisher or applying water risk splattering and spreading the fire. A safer choice is to smother the fire by covering a pan with a lid or closing the oven door.

The NFPA advises these safety steps during cooking:

- $\sqrt{\phantom{a}}$  Don't leave cooking food unattended.
- $\sqrt{\phantom{a}}$  Roll up sleeves and don't wear loose clothing.
- √ Ban children and pets from a three-foot "safe zone" around the stove.
- √ Keep pot handles turned in to avoid spills
- √ Keep pot holders, dish towels, food packaging and other clutter off the stovetop.
- √ Clean cooking equipment; built-up grease can catch fire.
