Your state association works hard for you year round. It costs thousand of dollars each year to keep people in Frankfort on your behalf. State aid is at an all time high. Yes, there are some difficulties. Yes, the current system is not perfect. But your involvement in the system will help make it better. If you are unhappy with the way things are going let those in the various positions know you are unhappy. Do not

take out your frustrations on the KFA. We are not the enemy. We are, for the most part, the only friendly voice you have when legislation is being drafted.

Dues collection to the association is at an all time low. What does that mean? That means that many departments are riding on the backs of those departments that are paying dues. We of the KFA must take some measures to insure a balanced budget. To do that, beginning with the October issue of the Smoke Signals II, the only departments receiving the newsletter will be the dues paying members. There is an application on the back page for you to pay your dues. We do not want to take these steps but the solvency of the association is our current main concern.

You might ask "What benefits do I receive from the KFA anyway?" The answer is simple. Benefits include:

- 4. Help with line of duty deaths and firefighter funerals.
- 5. Bi-Monthly newsletter to keep you up to date on all local, state, and national issues.
- 6. A Bi-Annual form where local associations can network and plan activities with other associations.
- 7. An annual conference with a memorial service to honor brother and sister firefighters who have moved on to other responsibilities on a higher plane.
- 8. A network of directors and vice presidents who are available to assist you with your local questions about your association.
- 9. A link to the National Volunteer Fire Council where you have a voice in National Fire Service Issues.
- 10. National 1-800-Fire Line service to help locate local departments for those interested in becoming a local volunteer.
- 11. Maintenance of our Firefighter Memorial in Frankfort.
- 12. A scholarship program that helps our membership with educational costs.

All in all your state association is a bargain for the small \$75.00 membership fee.

#### Treasurer's Notes

Second notices for memberships have been mailed out and

we appreciate all of the departments that have sent in their membership dues. I continue to believe departments receive much for their \$75.00 annual investment in the Association. Membership dues run from October 1st through September 30th.

Many Kentucky departments choose not to pay their dues. We could be an even stronger Association if each department would make this \$75.00 investment. Our Association struggles to fund services for all of our Kentucky departments, including those that do not pay dues. We now realize with the cost of providing services going up we can no longer do this.

We believe one of the best services offered by our Association is Smoke Signals II, our Association's newsletter. We have been providing one copy of Smoke Signals II to each department, whether the department is or is not a dues paying member. The cost of providing the Newsletter is just over 18 percent of our annual budget. KFA will cease providing this service to non-dues paying departments after the August 2002 issue. This change will not affect individual subscriptions to the newsletter.

Woody Will continues to serve as Editor of the KFA Smoke Signals. Each publication is packed with information and arrives on time, every time.

We have had a contract with Civic Development for some five years to raise funds for the Association through a telephone fund drive. Of our annual budget, 42% is raised by this organization. The contract with Civic Development has been renewed for the next three years. The new contract provides for some additional revenue which we hope will allow us to build some savings for future projects. The Association continues to seek out other means of generating revenue which would allow us to end the telephone fund drive.

I was at our Kentucky Fallen Firefighters Memorial in Frankfort on July 11<sup>th</sup>. I was reminded while there that we have many more pavers for sale.

This is a great way to honor someone from your community or even placing your department's name on a paver. Sylvan Smith is coordinating sales of the pavers.

I regret the departure of Gary Clarke from the Executive Board. Gary brought a variety of experiences to the Board providing some great insight into issues before the Association. I look forward to working with Mike Giordano as he assumes this position.

Paul Billings from Real West Kentucky is providing some great leadership to our Scholarship program. To provide more scholarships the Association needs to continue to sell our KFA prints. Please help the Association continue to promote these prints. For questions on the prints or the Scholarship program please contact Paul.

Most are aware of the passing of Governor Wallace Wilkinson. The KERA Educational Reform Act and the lottery were passed during his administration. After his death, I read for a second time his 1995 book "You Can't Do That Governor". Governor Wilkinson was not suppose to win the governor's race according to all of the polls, yet he did. In reflecting on this in his book, on page 25, he reminded readers that the only statewide group to endorse him as a candidate was the Kentucky Firefighters Association. I just thought this was interesting.

As you read this we will be closing my fifth fiscal year as your Treasurer. During these five years we have handled just over \$950,000 in transactions. We have had many great accomplishments during these five years: building the memorial, beginning to award scholarships, increases in incentive pay and state aid four years in a row, providing public safety education training, starting the web page, providing a great state newsletter (Smoke Signals II) and the list goes on and on. I have the great opportunity to see the accomplishments of all of our committees. I can tell you there are many great leaders within KFA that work extremely hard to benefit the fire service of this Commonwealth.

During these five years we have handled just over \$950,000 in transactions and just under 7,000 pieces of mail going out and coming in. We are required to provide reports to multiple agencies including the Legislative Ethics Commission,

Federal Trade Commission and Federal Communications Commission, and the Kentucky Attorney General's Office.

Robin Long, Fire Rescue Training Area 3 Administrative Assistant, spends many hours of her own time helping me handle all of this work. Without her, I could not serve as your Treasurer. Robin, I thank you!

#### **FIRE COMMISSION**

As this is being written the Fire Commission is in the process of

reviewing applicants for the position of Executive director. A new Director may be named by the time this issue is distributed.

For those that participate in the incentive program, please remember that in order to receive your incentive funds in a timely manner, your request should be in the Fire Commission office by the 5<sup>th</sup> of each month. Should you fail to submit your request on time, payment for that period may be delayed for several months.

If you are applying for a low interest loan from the Fire Commission, the Loan Committee strongly recommends that you do not commit any funds (down payment) towards any purchase prior to your loan being reviewed and approved by the Loan Committee. A decision on your part to commit funds to a project prior to loan approval will not impact the decision of the Loan Committee. The loan application is being updated and additional information will be required to allow the Loan Committee to better evaluate the applications. Additionally, should a department pay off an existing Fire Commission loan, that department will not be considered for another loan for a period of 6 months. All loan application information must be received in the Fire Commission office by the 10th day of the month preceding the month of the Fire Commission meeting. Fire Commission meetings are normally held in even numbered months.

#### 'Fire Commission" continued . . .

With the new fiscal year (FY) just under way (July 1) it is an opportune time to explain the finance of both the State Fire Rescue Training program and the Fire Commission. While the goal of both programs is to train the fire service, funding for each program is separate and independent. Therefore, short falls or over runs in one program cannot be covered by the other.

The State Fire Rescue Training program is funded by state appropriation and any revenue generated by industrial training classes. Although the funding has remained steady over the past several years, it has not been able to keep pace with inflation and mandated state employee raises. In fact during last year's state funding shortfall, the state appropriation was reduced by 2%. The new fiscal year budget saw an offsetting increase to the fund but it is projected to again fall short of inflationary expense increases and the anticipated 2.7% state employee raises.

To combat the shortfalls the biennial budget that was submitted to the State Accounting office requests an 80% increase in funding to cover the instruction necessary to maintain certification, funding for regional fire schools, and updating equipment for all SFRT areas.

The Fire Commission's budget is funded by a surcharge assessed on property insurance. All revenues collected by this tax is split between the police and the fire. At one point the split was 54% police and 46% fire. Currently this split is 72% police and 28% fire. These funds can only be spent on items in the Kentucky Revised Statutes or items that have been approved by the budget process. This year both the Fire Commission and State Fire Rescue Training program are operating on a continuation budget. This means that only statute items can be funded. These items include Incentive, Hepatitis B inoculations, Training Facility Grants, the final draw to fund the Loan Account, State Aid to Volunteer Fire Departments and Worker's Compensation, which alone increased \$450,000 for the current fiscal year. For FY03 these items equate to 99% of the receipts. This figure does not include the operating expenses of the staff office, which by statute is allowed to be no more than 5.0% of receipts.

This ultimately means that we are going to have to use carry forward funds to operate.

Another difference in the financing of the two programs is the timing of the receipts. For Sate Fire Rescue Training the total appropriated funds are available July 1. The Fire Commission funds are collected daily with the largest receipts occurring around the 22<sup>nd</sup> of each month. The Fire Commission cannot run in a deficit therefore monies have to be collected before they can be spent. Incentive payments have to be paid monthly while Worker's Compensation premiums are paid in July and January. For this reason State Aid has to be pushed back to January – March as a worse case scenario. If revenues are up and cash is available to cover State Aid awards disbursements will be moved forward to November or December.

Some departments have voiced concerns about equipment loans with their local banks that rely on the State Aid awards to pay their yearly payments. It has been discussed that some banks may accept a letter from the Fire Commission explaining the delay in the awards due to our funding issues and that these banks may be willing to move the annual payment to coincide with the State Aid payments. ## D.C. Firefighters Face Discipline for Volunteering

About 40 District firefighters are facing disciplinary proceedings and possible expulsion from their union because of their voluntary service to Prince George's County fire companies.

The firefighters are in apparent violation of a new regulation that the International Association of Firefighters (IAFF) has imposed on local chapters barring union members from serving as volunteers while off-duty.

Raymond Sneed, president of IAFF chapter 36 in the District, said Monday that disciplinary proceedings have begun against 41 members of his chapter who have allegedly violated this union order. Hearings are to be held by the end of July, Sneed said, and those who are found in violation could be expelled from the IAFF. Those expelled would, however, be able to keep their jobs with the District fire department.

"It's one (union rule) that we all have to live by," Sneed said.

The regulation identifies volunteer companies that operate alongside paid personnel as "rival organizations" and prohibits union members from joining them. Officials from IAFF Lodge 1619 in Bowie introduced the regulation as a resolution at the national convention in August 2000. Union members passed the resolution and it took effect in 2001. IAFF Lodge 1619 represents county firefighters. The firefighters facing disciplinary proceedings serve on several different volunteer companies, Sneed said, but he would not identify which Prince George's County stations could be affected if their members are convicted of union violations.

"I know it's the whole county (that's affected)," said Sneed, a Lanham President.

Sneed said there are about 1,300 active members in his IAFF lodge. Disciplinary proceedings against the firefighters were started after officials with the county IAFF chapter sent letters to neighboring chapters in January listing members in apparent violation of the union regulation.

Thomas McEachin, president of the local chapter, said at the time that the Prince George's County chapter was merely trying to enforce a union rule that all members were expected to follow.

Members of the Maryland State Fireman's Association, which represents volunteer emergency workers throughout the state, have opposed the union's actions and claimed the loss of union membership would adversely affect the volunteers' careers.

Frank Underwood, spokesman for the Prince George's County Volunteer Fire and Rescue Association, said his organization plans to resist any disciplinary actions taken against county volunteers.

The local association has formed a task force to deal with the situation, Underwood said.

"We are going at this with dignity," Underwood said of the volunteers' stance against the union. "We have to keep our act together."

The volunteers' efforts received a moral boost this month when the U.S. Department of Labor decided that professional firefighters in Montgomery County do not need to be paid when they volunteer their services.

Montgomery County had banned full-time firefighters from serving as volunteers after a 1993 federal decision ordered firefighters to be paid overtime for their voluntary work. But the recent ruling, announced June 5 in a letter to county officials, reversed that earlier decision.

"We conclude that the (Fair Labor Standards Act) does not require Montgomery County to pay its career firefighters if they volunteer, freely and without coercion, to provide services to the nonprofit fire and rescue corporation in the county," wrote Tammy McCutheon, administrator of the federal agency's Wage and Hour Division.

Underwood said Monday he was pleased with the federal decision because it supports volunteer activity.

"When you get off of work, you can do what you want to do," Underwood said.

"That helps us out that way."

But Underwood conceded the ruling does not have a direct impact on the local controversy.

McEachin said he was displeased with the recent federal ruling, but he also does not believe it will affect the local situation.

"It's a disappointment, but it is what it is," McEachin said.

Capt. Chauncey Bowers, spokesman for the Prince George's County Fire/EMS Department, said the dispute is a union matter and that the county department has no position. According to 2002 budget documents, there are 696 paid firefighters in Prince George's County and about 1,375 active volunteers.

## FEMA Awards First Seventy-Two FIRE Grant Awards

WASHINGTON - The Federal Emergency Management Agency (FEMA) and the United States Fire Administration (USFA) have announced today the first 72 Assistance to Firefighters Grant awards.

The USFA is a part of the FederalEmergency Management Agency.

These awards will be used to increase the effectiveness of firefighting operations, fire fighter health and safety programs, new fire apparatus, EMS programs, and Fire Prevention and Safety Programs. FEMA and the USFA will be announcing a total of 5500 grants over the next five (5) months.

The total of all awards will represent a \$360M investment to enhance fire and EMS service delivery throughout the United States. Today's announcement represents \$3.9 million to these 72 departments.

"As recent history has shown us, this nation's fire departments are the first responders into almost every emergency." said FEMA Director Joe M. Allbaugh. "Through this award program, President Bush has provided FEMA the opportunity to improve significantly the safety of these men and woman, and the Fire and EMS services they provide to Americans."

More than 19,900 fire departments - volunteer and career - applied for grants this year, submitting requests totaling approximately \$2.98 billion.

The grants, authorized by Congress, will be used to assist rural, urban and suburban fire departments, in all 50 (fifty) states. The FY2002 grant applications have been through an exhaustive peer review by over 300 representatives of fire service organizations.

The most current list of successful applications and awards is posted on the USFA web site at www.usfa.fema.gov/grants. Future grant recipients will be listed as awards are made.

Additional information on the rewards process:

- \* According to FEMA/USFA there were 19,584 submitted applications.
- \* FEMA/USFA currently estimates that as many as 5,500 awards will be made.
- \* FEMA/USFA also estimates that by the end of calendar year 2002 all 5,500 awards will be processed and announced.

## Bonnieville FD Receives new Rescue-Pumper

The Bonnieville Vol. Fire Department has taken delivery of a 2002 Central States Rescue-Pumper. Located in Hart County, on I-65 the Department experiences a large volume of Interstate calls. Because of this, a number of issues were taken into consideration in the design of the new apparatus.

The appartus was purchased with a top mounted pump panel to keep the operator out of traffic. Roll up doors also decrease the required working space around the pumper. The appartus has rear mounted 1 1/2 outlets instead of cross lays.

The pump is a 1250 GPM Darley with a Lifetime Warranty. The tank is a 1000 gallon UPF Poly Tank. The chassis is a Freightliner FL-Series with a Caterpiller Engine and an Allison Automatic Transmission. Use of the Caterpiller Engine allows us to obtain "in station" warranty & service through Wayne Supply Co. the local Caterpiller agency. All emergency lighting and warning devices on the apparatus are Weldon. The pumper was sold to the Bonnieville FD by Fire Apparatus Div. S.D.C.

In her nervousness, she forgot to pull the pin. The instructor hinted, "Like a hand grenade, remember?" In a burst of confidence she pulled the pin and hurled the extinguisher at the blaze.

## The Dangers of Live Fire Training

I don't know if you have been following the events that are unfolding in the case of the Lairdsville New York Fire Department. It seems that on September 25 the department was conducting a house burn in a vacant structure in Westmoreland New York. The house burn went bad and 19 year old recruit firefighter Bradley Golden (who had been a member for three weeks) lost his life. Firefighter Alan Baird III was tried for second-degree manslaughter. I will not get into many particulars about the case you can read the details for yourself on firehouse.com. There are several points I want to make about this and other house burns that will be taking place as Summer moves along into Fall:

- 1. Follow NFPA 1403 to the letter. It will keep you safe and you can still train.
- 2. Make sure all students have had the minimum training as required by 1403 before they take part in the live fire burn.
- 3. Assign a safety officer that has no other responsibility during the burn.
- 4. Enlist the help of experienced training officers to conduct the burns.
- 5. Do not use any kind of flammable or combustibles liquids to make sets.
- 6. In the pre burn briefing, make sure students are familiar with the structure and all means of egress.
- 7. Provide for a rehab area as well as ambulance coverage during the burn.
- 8. Make sure all permits and insurance forms have been signed.
- 9. Use the check list as provided in the back of NFPA 1403.
- 10. Use an effective personnel accountability system. Make sure everyone is accounted for at ALL times.

The case is history now. Please take the time to go to the Firehouse.com website and review the case. As in all trials accusations were flying and the department was and is suffering. I do know that as much as I don't want to see that happen here in Kentucky it is really only a matter of time. Please follow NFPA 1403 any time you decide to do a live fire training exercise. Be safe and may God bless the firefighter.



## Kentucky Chapter International Association of Arson Investigators

The Kentucky Chapter, of the IAAI, conducted its annual general membership meeting during

Arson III begins with legal aspects of fire investigation, continues with scene investigation at training burns and concludes with presentation of facts in a courtroom setting, utilizing experienced attorneys. Almost 80 firefighters attended this program this year; thanks to each of them and to anyone that stopped and spoke with us at our booth in the exhibit hall.

## Membership

KFA By-laws regarding Membership
