88th Meeting of the Annual **KFA Conference a Huge** Success!

August 2nd through the 5th was the annual meeting of the Kentucky Firefighters Association at the Drawbridge Inn in Ft Mitchell KY. By anyone's standards it



was a great success. President Dailey and the Northern Kentucky Firefighters were wonderful hosts and hostesses. On Saturday, 2 August 2008, the Annual Olympic competition took place at the Villa Madonna Academy. It was hosted by the Crescent Springs FD. In the adult category the Parkers Mill FD came in first for the third year running, while the Erlanger FD took second place followed by the Southgate FD. In the Explorers group Alexandria Team # 1 took first place followed by Southgate, and Union #2.

The Sportsmanship award in the adults went to Parkers Mill and to the Hebron FD in the Explorer group.

Our thanks go to the Crescent Springs FD, the Benediction Sisters, and of course to our good friend and long time KFA supporter Mr. Steve Siereveld of VFIS for the trophies.

On Sunday a parade of fire apparatus took place at 2:00 pm that originated at the Drawbridge and ended at the World Peace Bell in Newport, KY. There the annual memorial service took place. Three "Line-of-Duty" deaths were recognized with their family members on hand to receive the flag case from the KFA. White doves were released at the conclusion of the service with a helicopter fly over. Sunday evening was capped off with an Oktoberfest at the Drawbridge.

On Monday the business meeting began with reports from the various agencies serving Kentucky's Fire Service and reports from our KFA officers. Officer nominations were held as well as non prefiled resolutions from the floor. On Monday evening the conference attendees were treated to an excellent dinner aboard a paddlewheel boat on the Ohio river.

On Tuesday morning business was conducted along with the announcement of the Hall of Fame inductees. They are: Mark Luckett, Mike O'Day Sr., Ken Knipper, and VA Beam. Reports continued along with nominations from the nominating committee. The nomination for the third vice president was for Chief Bob Hendricks of the Lexington FD. Bob is very involved with the KFA and will make a wonderful president. The conference was topped off with a wonderful banquet on Tuesday evening. Come on firefighters make sure your department is a member and its dues are paid. Well I have went on long enough. Remember the \$2,000.00 life insurance policy for each of your department members is tied to your department belonging to the K F A. This policy does not cost you or your department anything, it is FREE. That is a cheap policy and benefit for your family should you be die in an accidental death. Most of the programs the K F A is involved in, are subsidize by the dues and sustaining memberships. Please have your department become a member of the K F A.

Many things will be taking place this year. I know the two committees I sit on will be rewriting the Scholarship requirements and the Constitution and By-Laws need some additional work. Your Executive Board is very active. But, unless your department calls upon us, we do not know what your problems are. Get involved, call your Vice President or Director and ask what is going on. It is the only way to communicate until the next Executive Board meeting or next year's conference in Pikeville. Hello from western Kentucky and the Jackson Purchase Firefighter Association! Fall is in the air in western Kentucky and we hope all is well with you as well.

The JPFA is busy planning for the 2009 fire school. A recent school planning meeting was held and 2009 looks to be a great year for the annual JPFA fire school. Several popular classes from 2008 will be back and we're working to make 2009 the best fire school yet! Information will be in the mail and online at <u>www.jpfaky.com</u>.

This is about the time of year we start hearing feedback on grant submissions. One of our local JPFA departments received a suprise when they were approved for a grant that they originally thought they didn't receive. The Grand Lakes Fire Protection District in Grand Rivers, KY received notice on September 3, 2008, that they were recipients of a \$70,159 AFG program award. Funds from this grant will be used to purchase new handheld radios and pagers for all members of the department as well as radio headsets for many of the trucks. The department submitted their 2007 AFG application and then received a rejection notice in February of 2008. Captain Ken White with the Grand Lakes Fire Department said that when the 10-question e- mail came in from the AFG Program Office with 2007 information, it was a bit confusing at first since the award amount did not match up with the communication grant submitted for 2008. Then, a phone call to Chief Troy Newcomb from the AFG Program Grant's Management Specialist confirmed that there were funds left over from the 2007 year awards and the Grand Lakes' 2007 application would be funded.

The JPFA would like to remind you to say thanks to our fellow emergency service workers with the Red Cross and EMS. We've recently had several families in the western Kentucky region to lose their homes to fire, and these groups prove to provide great assistance both to the fire personnel AND the families who have lost everything.

All of the JPFA member departments hope you have a safe fall. As we have just passed 9/11 remember our overseas troops and keep them in our prayers.

MIDDLETOWN FIRE PROTECTION DISTRICT ANNOUNCES NEW CHIEF

After a National search for candidates, the Middletown Fire Protection District (MFPD) Board of Trustees has named a new Fire Chief. Middletown Assistant Chief Jeffrey Riddle, Sr. will take over as Chief on October 1, 2008. He succeeds Chief Donnie Brooks, who will retire in October after 35 years of service with MFPD.

Riddle has served 19 years with MFPD, the last eight as Assistant Chief. "I am honored that the Board has selected me to become Chief," Riddle said. "My home is the Fire Service and Middletown. I will do my best to see that MFPD continues to provide the best service possible to our residents."

The Board of Trustees searched for nearly eight months before naming Riddle to the Chief's job. "We had candidates from California to Virginia expressing an interest in this position," said Ron Wolf, Chairman of the MFPD Board. "Jeffrey's selection as Chief is confirmation that we do have the best individual for our department."

Lyndon Fire and Rescue Selects New Chief Russell Rakestraw announced as New Fire chief of the Lyndon Fire Department. After 26 years as the Fire Chief, Chief James Baker announced late last year his plan to retire in July 2008. The Board of Trustees formed an Executive Search Committee in the fall of 2007 to help select a new Chief as his successor. The committee received over 20 resumes for the position, including candidates from outside the state. Russell Rakestraw was selected as the top candidate to fill the position of Fire Chief upon Chief James Baker's retirement in July.

"He'll move our department forward where we need to be," said Chief Baker. 'I'm glad Russ was able to apply for the position and get the job."

We are excited to announce the 2009 Officers School is moving to Lexington! Everyone has been asking about the future of the Officers School. We are writing to give you the plan for the future of the Officers School.

The Executive Inn Rivermont, home for the Officers School for the past 20 years, has been in trouble since the fire of 2006. Some would say it was in trouble before the fire. On June 9th, the Executive Inn closed and is not expected to open anytime soon.

An additional problem for the Officers School was the fact that the Officers School had grown as large as it could within the Executive Inn. There were no more class rooms and no more exhibit space.

The Green River Officers and the Area 3 Fire Rescue Training staff were into on-going discussions about how to expand the Officers School when the Executive Inn made the decision to close the hotel.

To host the Officers School we need 21 class rooms, 33,000 square feet of exhibit space and 560 hotel sleeping rooms per night. The Green River Association searched for a location with a conference center and hotel of sufficient size and economical prices for our participants. The best proposal came to us from Lexington.

Lexington has the number of classrooms needed, the expo space needed, the hotel sleeping rooms needed, is the most affordable for both the Association and the students, and is the closest to the Green River area meeting all of these requirements.

The Officers School will be at the Lexington Convention Center / Heritage Hall (attached to Rupp Arena), the Lexington Downtown Hotel (formerly the Radisson) and the Hyatt Hotel. In this 5-day course, fire officers are introduced to the Incident Command System (ICS). T h e y study proper fire command techniques for control and extinguishment of fires ranging from small, residential structures to multi-occupancy, commercial complexes. Topics covered include problemsolving and fire command, interagency and mutual aid, the ICS, incident management, size-up and strategy, tactics and action plans, truck company operations, engine company operations, building construction and fire behavior, pre-incident preparation, incident organization, and strategic command. Special emphasis is placed on firefighter safety.

This course is designed for Chief Officers or Company Officers who have command responsibilities at emergency incidents. Additionally, officers who are upwardly mobile in their organizations may be considered. A letter from the fire chief on department letterhead will be required for these applicants. Fact finding trip to Barbados By Henry Goodrow

The Chief of the Barbados Fire Service said he was sending to Louisville, Kentucky the future leaders of his Fire Department. His goal was for them to gain as much training, information, and skills then return to complete his terminal objective of improving the Barbados Fire Service.

In August 2007, five (5) Firefighters came to Louisville to start their journey toward the complication of the Associate Fire Science Degree. These same Firefighters will be returning again in August of this year

On April 27, 2008 I left on a fact finding mission in the beautiful island of Barbados, West Indies.

The "Queen's" English is spoken everywhere but the local slang can be confusing. An American dollar is equal to two Barbados dollars. I had forgotten this small item and at first I was seen as a really big tipper.

A little history of the island, Barbados was an English colony until November 30, 1966 when it

became an independent state in the Commonwealth of Nations. Barbadians are the most literate nation anywhere. Everyone goes to school, which is free, and everyone is expected to succeed to their full capacity. The main industry is tourism, with sugarcane second. There was very little litter in the street; all of the Barbadians are ultra polite but the traffic makes our rush hour look like a walk in the park. The city streets were not designed for modern traffic and a two (2) lane one way street can become jammed very quickly.

So why should I go to the island? Well, if we at KCTCS are to properly instruct the Barbados firefighters and be assured they have a full and rounded training experience, we must have a working knowledge of the equipment used everyday at Barbados.

What is different? Fire is fire. Put the wet stuff on the red stuff. What could be different?

Since they were under the influence of Great Britain for so many years they use different terms for some things. To start, they call a Fire Apparatus an "Appliance ". And each "Appliance" and pickup truck carries two (2) fire hydrants. The water main connection for the hydrant is located in a small box in the roadway. Hook up is simple and quick since these boxes are usually located every 500 feet. In the "Non-water" areas the Barbados Water Company supplies tankers with which the appliance will nurse through out the incidents.

SCBA and full turnout are the order of the day at any working fire. The average temperature ranges from a low of 70 ° F to a high of 80 ° F and there is a wind moving the air all of the time.

While on the island I met with the Chief Officer staff on two separate occasions. Once giving them an update of the Incident Management System and then on the RIT and Accountability system presently used in Jefferson County. I also presented a training session on the problems and pit falls of being promoted from Firefighter to Station Officer for the senior Firefighters preparing for promotion. I also proctored a couple of ISFAC retests.

I was also able to observe the operation of the Command staff and the Firefighters at a working fire in a PVC pipe storage yard. Two days later I was asked during one of my sessions with the Chief Officers for my assessment of the operation at the

scene. I was able to give them a couple of ideas that would make their operations more efficient by working in the Incident Management System.

They had had three fatal fires just before I arrived and I was asked to look over the scenes and give my assessment of what could have made the fire attack more efficient. Since most building construction is of concrete or concrete block with a stucco covering, tin roof, and an open airy interior, the fires grow very quickly and the tin roofs, holding in the heat, makes entry at times untenable. In a fire situation the roof and upper floors and walls tend to come in quickly without the structure losing its integrity.

My stay was made most comfortable by the Command Staff, Chief Officers and the firefighters. I was taken on a tour of all the firehouses and that was very interesting. The island is the size of Jefferson County and served by only five (5) fire stations not counting the airport. The first due district of Headquarters and Worthing Stations cover everything from high rise concrete office buildings and residential, while in the outlying stations have heavy / light industry, tourists complexes and sugar cane fields.

Food? I have never missed a meal so I ate what ever was put in front of me or I just pointed and said I would have whatever that person was having. All of the food I ate was excellent.

Would I go back? Yes if they request me. My thanks to all of the Barbados Firefighters that made my trip so enjoyable.

WHEN AN OFF-ROAD RESCUE TURNS INTO A RECOVERY... CHAVIES, KY

When all evidence points to the improbability of the continued survival of the subject of a search or rescue, we in the business of "Emergency Response" are faced with the decision of changing the mission status from a "rescue" to "recovery." At this moment, the Incident Commander changes the focus of the mission from "saving a life" to "providing closure for family and friends of the presumed deceased," while limiting additional risk to rescue personnel in the process. Anyone making this decision does so only after consideration of cumulative facts; usually collected over an extended period of time. Once the decision has been made, if we perform a recovery professionally, with dignity and respect for the victim's body, and maximum consideration

for the safety of all involved, emotional impact on the family and rescuers alike is reduced. Often, that's the best we can hope for.

GCVFD operates a Yamaha 450 Rhino 4X4 "Side-By-Side" donated by "Andy's Cycles" of Hazard, KY. GCVFD's "All Terrain Res-Q Trailer" was donated by Yamaha Motor Corporation, USA.

At 22:55 hours on Wednesday, June 18, 2008, Grapevine - Chavies VFD received a dispatch from Perry County, Kentucky, E911 Center. The dispatch stated:

"A caller is reporting a man who had been 'ginsenging' on a mountainside north of Chavies, KY, is now trapped, and they need a basket stretcher to get him out."

Upon arrival at the scene as it was dispatched, assistant chief Ben Stidham, FF/EMT, was told the patient was 200 to 300 feet over an embankment where a man using a flashlight was signaling them. Given this information, Stidham proceeded down the embankment until he reached the man with the flashlight. At this location, Stidham was informed that the patient was actually another 500 feet down the mountain with his brothers at his side. After assessing the terrain, it was determined there was no established trail down to the position of the victim: in reality, it was close to a cliff. So, Stidham carefully proceeded ahead of other rescuers, who were in the process of preparing to perform a rope rescue, until he made contact with the patient's two brothers. It was at this moment that Stidham was informed by the patient's brothers the patient was, in fact, deceased, and had apparently been so for hours. Both brothers reported their last communication with the victim had been 12 hours earlier. At 9:00 PM, about dark, the family began to look for him. Upon locating his body almost 2 hours later, one of the brothers got word back up the hill and directed a younger family member to call 911 requesting assistance. However, because of separation between the on-scene family members and the 911 caller, the patient's condition was not accurately conveyed to the dispatcher.

Now past midnight, and finally on scene, Stidham changed the status of this mission from a "rescue" to a "recovery." He directed GCVFD personnel to reposition to an old washed out coal road about 1000 feet below their present location. Once the road was located, a "joint command post" was established at the point where the road became impassable by conventional 4X4 vehicles. GCVFD transported their Yamaha Rhino 4X4 "Side-by-Side" off-road utility vehicle and "All Terrain Res-Q Trailer" to the combined CP and staging area. Some time during this process, it was determined the victim's location was actually just inside Breathitt County, Kentucky. So, the Breathitt County Coroner responded to the CP. Given the location of the body and the terrain, it was determined that a removal by GCVFD's "Rhino Res-Q Team" was the safest and most expedient method available. Three hours later, with assistance from the Pine Branch Coal Company, and members of the victim's family, the deceased was brought out and delivered to the Breathitt County Coroner where he was officially pronounced dead.

It was later determined that this recovery required a combined round trip of 16 miles traveled over a washed out coal road on a steep mountainside; impassable by most off-road vehicles. What could have taken over 10 hours was achieved in just under 3 hours with the right equipment. In the words a paramedic on this mission:

"It (the Yamaha Rhino and All Terrain Res-Q Trailer) was the only way to get it done!"

To those who ask: "He's already dead, why not wait till morning to haul the body out?"

Remember, the two brothers who were with the deceased knew where the body rested? Now, consider additional family members who had gathered to be with their fallen brother once word got out that he was gone. In the Mountains of Eastern Kentucky, cohesiveness of "Family" remains strong. Weighing this, and GCVFD's off-road rescue vehicle and trailer already in staging, the decision was made to perform the recovery.

Upon the successful completion, family members thanked rescuers for not letting their brother lay out there all night. As previously stated about a "recovery" mission:

"Once the decision has been made, if we perform this act professionally, with dignity and respect for the victim's body, and consideration for the safety of all involved, the emotional impact on family and rescuers alike is reduced." Good job Grapevine - Chavies VFD!

We encourage everyone to evaluate their home situation, YOU MUST HAVE A SMOKE ALARM, that warning can save your life, create a home escape plan, practice and be sure all members of the house know two ways out of every room, be sure there is a safe meeting place and call 911.

Risk Watch is still our main safety initiative, we want to thank Ronnie Day, Executive Director and the Kentucky Fire Commission for providing our teams with 100 sets of the Ready for Risk Watch Activity Books for our schools. Our Public Education Committee is prepared to speak with your schools to provide Train the Trainer Workshops to expand and enhance our Risk Watch Program.

Team Member, Rusty Todd and his committee are working on the details to provide a Public Education Seminar for our Fire and Life Safety Educators in November at the Cumberland State Park in Somerset, Kentucky. Be sure to secure these dates November 21, 22 & 23 for a very special weekend of networking, educational opportunities, and a very special training session. Unfortunately the final details for this seminar have not been completely worked out, however, once done word will go out for our people to sign up. We are limited to 60 spots but your only expense for this workshop will be getting yourself to the facility in Somerset. Ken Knipper, Director Bryant Stiles, Alternate Since the conference I have had numerous questions regarding the Volunteer Responder Incentive Protection Act (VRIPA), which protects benefits up to (\$360.00) from taxation. Under VRIPA these benefits are not considered income and are not subject to Social Security or other payroll taxes. President Bush signed VIRPA into law on June 17^{th.} Be assured that this is now the law and you should advise your organization of this law. If you have any questions, please email me or Bryant.

I also reported on the Revisions of the Ryan White Act that removed the notification requirement that protected emergency responders by requiring a receiving medical facility to notify the responders if there was evidence of any infections or disease. We see that this is going to be a tough fight to get these provisions back into the Act. If you would contact your legislator regarding this issue, it would help us deal with congress. Let me know if you have a legislator who is willing to champion this issue.

Another item I reported at the conference dealt with the new upcoming safety vest requirements. I've had many questions on this issue. Here is what I am doing. I have asked the National Highway Transportation Administration for any documentation they have on this requirement. I am putting this together and plan to have Dave Jansing and the Fire Commission send out the information.

I have been reporting on the many developments in the EMS field. At the present time there is more activity than at any time I can remember in the last ten years. This past week I attended a meeting in Washington that included some of the best minds from Italy, Belgium, Nova Scotia, Canada and other countries.
