On December 28, 2006 Firefighter Cecil Tackett, Jr. with Flat Gap Fire Department lost his life in a motor vehicle accident while on his way to the fire station where he was participating in a fire department function. He was 28 years old and is survived by his wife and

two children, a 7 year old and a 3 week old. He had been with the department for approximately 4 months. Please remember this family in the weeks and months to come. They will need your prayers and support.

What's all this fuss about Firefighter Fitness?

At its December meeting, the Kentucky Fire Commission voted to spend money on the CPAT system of fighter fitness. CPAT stands for Candidate Physical Ability Test. This system was a result of collaborative effort between IAFF and ICHIEFS and 10 of North America's leading fire departments and unions through the Fire Service Joint Labor Management Wellness/Fitness Initiative. We continue to kill about 100 firefighters a year in the line of duty. According to a recent US Fire Administration study "Firefighter Fatality Respective Study 1990-2000" 46.6% of the deaths were caused by Overexertion/Strain. That simply means the firefighters were not in the physical shape enough for the task they were asking their bodies to do. Your body is a complex chemical/electrical/biological machine. It works muscles to move levers (your bones) to do tasks. You would not put a VW Beetle engine in a pumping apparatus would you? At the same time you can't asked an out of shape human body to do tasks it is not in the physical shape to do. Wise up take care of yourself. You are all you got!

Office of the Kentucky State Fire Marshal

According to Kentucky Archives, the State Fire Marshals Office was 100 years old in 2006. As far as we know, there has been no history written about this office. The SFM beginning in 1906 was fire prevention and rates. It is reasonable to assume that the rate segment was regarding insurance rates for properties in the state. Additional research should provide more information, which should be interesting. Sorry we don't have more, but what we do have was discovered by accident. We still may be able to celebrate this event in 2007 along with the anniversary of the 1977 tragedy at the Beverly Hills Supper Club. We have some great opportunities to generate awareness for Fire Prevention. Should you have some important historic information about the KSFM Office please feel free to share that information with us.

The department issued a "Truck Transportation Bulletin" on November 21 of 2006 about the recent frequent occurrence of truck fires in the Commonwealth. The probable cause of these fires is linked to the recent changes made to diesel engines. Diesel fuel in previous years has remained below its flash point in vehicle tanks. However this has changed. As diesel fuel is delivered to the engine and returns to the vehicle tank it is above its flash point. Diesel fuel normally has a flash point of around 130° Fahrenheit. Some reports state that the fuel in vehicle tanks after a hard run can reach temperatures of 150° Fahrenheit.

Diesel fuel vapors ignite at temperatures lower than that of gasoline. Diesel vapors can be ignited by ignition temperatures of about 494° Fahrenheit. Gasoline vapors require ignition temperatures of around 536° Fahrenheit.

It is therefore determined that a diesel unit which has been in service can have diesel in the tank that is volatile. Diesel vapors ignite if released in the presence of an ignition source which is rather low in temperature. The catalytic converter which can reach temperatures as high as fifteen hundred degrees is more than sufficient for ignition. This phenomenon can also be a danger to first responders if adequate ignition sources, such as saws or hydraulic rescue tools are in use during rescue and recovery operations.

Therefore those responding to highway accidents and agricultural incidents involving diesel powered equipment should be aware of the danger of flash fires when a diesel vehicle of recent manufacturing is involved and take proper precautions.

Governor Fletcher Deliverers Fire Truck Governor Ernie Fletcher visited Winchester av December 7 to deliver a new fire truck for

today December 7 to deliver a new fire truck for the Clark County Fire Department. A \$250,000 Community Economic Growth Grant (CEGG) was used by the Clark County Fiscal Court to purchase the new vehicle. Funding will also be used to repair existing fire trucks.

"Fire protection is critical to the safety and wellbeing of Kentucky's citizens," said Governor Fletcher. "The purchase of this truck will help alleviate equipment failures as well as ensure Clark County firefighters have the tools they need to prevent future tragedies."

The Clark County Fire Department has worked through several recent challenges. Last year, a fire claimed the life of Ovie Berry, Sr., an 85-year-old Clark County resident. At the time, the fire department had two trucks that were not operating. This resulted in difficulty containing the large fire and prevented firefighters from gaining access to the home.

"Each year, fires cause extensive amounts of property damage and claim thousands of lives across the United States," said Senator R.J. Palmer (D-Winchester). "It is vital that we provide our first responders with the equipment they need to do their job."

On several occasions, the Clark County Fire Department had to borrow a truck from Lexington-Fayette Urban County Government, for periods of up to two months at a time.

Representative Don Pasley (D-Winchester) said, "This truck will mean so much to the residents of Clark County. This project will provide better public safety for all of our families and children."

"With the extended growth in Clark County, we felt it was extremely urgent that we pursue this CEGG funding for basic services for the citizens of Clark County," said Clark County Judge Executive John W. Myers. "We need to ensure that our fire fighters work with updated equipment for the safety of not only our fire fighters, but for the safety of the public as well."

The CEGG program, which was established during the 2005 General Assembly, provided nearly \$10 million in grant funds to be allocated during the 2005-06 biennium. The program is administered by the Governor's Office for Local Development (GOLD) through the Office of State Grants. The goal of the program was to provide flexible funding to support and encourage the economic growth.

Here I go pushing it again. Actually I have been very busy this fall representing the NVFC on a number of EMS and Homeland Security projects in Washington. There is no doubt that the NVFC works hard every day for America's volunteer fire and EMS services and members.

The NVFC has been involved with projects on EMS Workforce Development and Pandemic Flu. These projects are important to the full EMS community.

The hottest news in EMS is that NHTSA has announced the formation of the National EMS Advisory Council. The Council will be a nationally recognized group of EMS and 911 representatives and consumers who will provide advice and recommendations to NHTSA's EMS program on a broad range

of issues. This group will consist of about 24 representatives of the EMS community. No member will represent a specific organization but will represent a specific element of EMS. Other information is available on the NHTSA web site.

In addition to the above, the NVFC has been involved with DHS's efforts to develop guidelines and policies on identification, background, and verification. We have also been involved in the development of the same for security clearance into a facility. Both of these projects are part of an effort to protect our emergency responders when responding to an incident of national consequence.

The NVFC has spent considerable effort to improve their web site. This site is available to anyone as you do not have to be a member to avail yourself of the information available on the site. I recommend that our firefighters and EMS personnel take a look at www.nvfc.org. While there take a look at the benefits of joining the NVFC. After I picked myself up off the floor, I went to this magical portal to see just how fabulous this web spot could be. I was pleasantly surprised. Now I am not silly enough to think that Charlie is maintaining the site himself. However, for him to admit that there is even a need for such things much less spend precious resources and time to own one almost boggles the mind.



This valuable resource is a must-have for all volunteer and combination departments who are experiencing retention and recruitment challenges.

Among the challenges identified and addressed in the new guide are time demands, training requirements, increasing call volume, changes in the "nature of the business," changes in sociological conditions, leadership challenges, federal legislation, internal conflict, higher cost of housing, aging communities, and the effects of the decline in volunteers. The text contains a thorough and insightful look at each of these issues and provides examples of solutions that have worked in volunteer organizations across the nation. There is also an expansive Appendix section that contains further information such as study results, statistics, sample documents, references, and additional resources. The NVFC and USFA originally teamed up in 1998 to release the first edition of the guide. This second edition has been enhanced with new research and current issues the emergency services face in the 21st century. The adventures of the Cross + Roads Fire Department By Woody Will Jr. and Sr.

It was one of those Sunday afternoons when you would rather be someplace else but it's your job so you just do it. I was watching television and out of the corner of my eye I could see firefighter Simmons pull something out of a brown bag. I didn't pay much attention to what he was doing but just made a mental note of it. I have learned that around the fire house it pays to pay attention to things even though they may not directly affect you. Supper was about ready when I heard the loudest blood curdling scream come from the kitchen. It was big old Captain O'Donnell. The most macho looking Irishman you could ever imagine. Firefighter Simmons had put a very real looking toy copperhead snake on the seat of Captain O'Donnell's chair. Captain O'Donnell pulled the chair out from under the kitchen table and the fun began. Now O'Donnell is not afraid of anything except snakes and he is terrified of them. The only problem is he could not figure out which one of us kept putting various toy snakes all over the fire house. He tried threatening, bribery, asking family members of people on the shift he even went out and purchased a secret camera and hooked it to a video recorder except everyone in the firehouse knew where it was so it didn't work either. Simmons was sly. He would always wait for O'Donnell to go to the John and make sure he was on a stool before he would start his game. It was a ball to watch how it all progressed. But this Sunday afternoon I was in no mood for games. A close friend of mine, Joe Abernathy, had received real bad news about bone cancer that was found too late to do much about it. I had been in prayer for him on Sunday morning when the Priest, Father Raymond, had stopped by the station for communion. Joe was a family man with two very lovely children, a loving wife and a good friend.

After supper we played cards for a while, watched the news and were off to bed. I had trouble getting to sleep with the news of my friend. I was awakened out of a sound sleep at 04:25 by the radio "Attention all Cross+Roads Firefighters. Attention all Cross+Roads Firefighters. You will be responding to a vehicle vs tree on Windy Lane Road off Highway 253". We got in the rescue rig

and were pulling out of the station when the responding ambulance told us we could slow our run down because the driver of the vehicle was 10-7. We pulled up on the scene to see a late model car of some kind had hit a tree dead center. The car had completely engulfed the base of the tree. No part of the vehicle was distinguishable. We worked for about two hours to free the body of the driver. Thankfully the driver was the only one in the vehicle. I was cooking breakfast when O'Donnell said "Say John, wasn't that a friend of yours in that wreak last night?" "I don't know Capt I didn't recognize the body and I haven't had time to look at the report. Who was it?" "It was Joe Abernathy." I could not believe my ears, it was all I could to keep my composure. How will Jill and the kids go on I thought to myself? Life is so very precious. We must live every day as if it may be our last. When I got off shift I went by the school just to kiss my kids and tell them I love them.



Chaplain's Corner

Frequently you hear some fire instructor say during training "What we need to do here is get back to the basics." What they mean is that some part of our operation looks as though we may have forgotten some of the basic elements or skills. We may need to go back and train on some very basic skill from the beginning. If you were a runner and you were going to run a 25 mile marathon you would not begin by going on a 3 day fast before you ran. No the basics teach us that if you are going to run your body needs a fresh supply of energy.
