and mutual aid!

Area 14, Campbellsville Fire/Rescue Training Center received a John Deere Gator to be used locally and in the region for mutual aid assistance, training and rescue missions.

The Gator was purchased through a grant from the U.S. Smokeless Tobacco Co. National Donation Program.

The keys to the Gator were presented to Jamia

Skaggs, administrative assistant for Area 14 Fire/Rescue Training by Robert Fields, department manager of US Smokeless Tobacco Co. of Nashville on May 9th, 2003 at a ceremony at the State Fire/Rescue Training Center 385 Old Greensburg Road. On hand for the ceremony were Charlie Shaw, Brenda Allen, Campbellsville Mayor, Paul Patton, Taylor County Judge Exec. and many more.

Realizing that a high rate of accidents involving children under 18 occur, the Gator will be used to teach proper handling of off-road equipment.



Also the Gator can be made available for emergency situations that require traveling into areas where the delivery of gear, or the rescue of an accident victim would necessitate the use of 6-wheel drive capability.

It is "time for risk watch", champion management team Kentucky, lead by fireman Joe, Tom Haynes & Robert McCool, Bob Douglas and Bonnie Pig are spearheading our Risk Watch in Kentucky project. After an outstanding introduction to Risk Watch seminar, conducted by Peg Carson, field advisor from NFPA and hosted by our good friends from Madison County (chief Murphy & Major Butch Kirby) held in February we were anxious for moving ahead. Our next journey took our champion management team Kentucky to Boston MA for a workshop on how to begin the Risk Watch Train the Trainer workshops. We secured enough knowledge, information and materials to begin with our five pilot counties; Pulaski - Perry - Madison - Meade and Taylor. Each county received enough materials for twenty classrooms and were provided the first Train the Trainer workshop to begin their project. Each county will build their own countywide coalition team of fire - law health and education professionals to expand and continue their existing Risk Watch projects. I am so very proud of our first coalition teams and members who are so dedicated and have made this commitment for the safety education of our children. Our CMT was delighted to provide the train the trainer workshops at State Fire School, Dixie Bowen Training Center and the Madison County Fire Headquarters in Richmond. We are also planning a Train the Trainer workshop at the regional fire school in Northern Kentucky at NKU on September 27th & 28th.

We are beginning the process of identifying counties for the 2004-05 school year. We will need ten counties. God bless and thanks to the fire departments, healthcare professionals and facilities that have taken the first step to bring risk watch to their communities. We promise to support and help all we can to make their efforts successful.

I believe with all my heart that together we will make Risk Watch the answer to helping our children to live safer and healthier lives. We want you to be a part of this project. Chaplain's Corner

Flashover

We just participated in some awesome training here in Lexington. Our training center built a flashover simulator and the whole department had the opportunity of experiencing the buildup to a "flashover" in a controlled environment. It was really some great training. It was first off a little strange to have 10 firefighters packed into a tin can with fire all around and everyone just watching. But it was really something to see the fire started at the incipient phase and build to the point of flashover. It was neat to watch as the smoke and heat build up to the point that we could actually watch a "rollover" occur over our heads. We could actually see smoke and gases igniting in what appeared to be fingers of fire as the "aroma" would reach out trying to find oxygen to live. We could feel the heat building through our turnout gear as the fire intensified. What we could not see is what our instructors talked about as "thermal radiant feed back" where everything in the room was getting to the point that they were reaching their ignition temperature and radiating heat and gases back to the source rapidly building to that point of everything flashing with fire. We could feel the heat building up on us as well. Had we not had a hoseline and a controlled atmosphere everything in the room including us would have been involved in a full blown flashover. There is that potential in most structure fires we fight. We are trained to watch for signs of flashover as well as techniques to use our fire streams to prevent flashover. This type of awareness, training and skills can save our very life. AA crew of firefighters could find themselves in deep trouble if they were not able to recognize the possibility of an impending flashover.

As I thought about that training, I wondered how that could be applied to our personal lives. I think many of us have already been involved in a flashover in our lives and many others may be very close or on your way to that experience. It could happen in our marriages, on our jobs, or just personally to us in some way. It happens just like in the fire setting. This personal flashover starts small with just getting a little off course in a relationship or a habit or way

of thinking. Once this thing is started, you have to do very little to help it grow. It will seek out what it needs to survive. All along without you recognizing the signs, you are lulled to sleep as this "animal" begins radiant feed back. It begins to affect every part of your life and each part begins to reach its ignition temperature. Things are not going right with your spouse. Your work relationships are suffering. You come home and kick the dog and scold the kids. You feel irritable and ornery and then "BOOM" it happens - Flashover - Everything in your life is on fire and you wonder, "how in the world did I get here?" It began with a little spark. A spark of flirting, demeaning your spouse or kids, taking short cuts at work, little white lies, or half truths. It started with just a little innocent fun we call it. "I don't mean anything by it" we say. Friends, we need to recognize signs of personal flashover. Is there more stress at home? Is there more problems with co-workers? Do you seem more agitated and short with others? Are you tempted outside your marital relationship? Has the joy in life gone? There is a fire raging somewhere. You find it and deal with it. If you don't do it now it may soon be too late.

You know I mentioned not being able to see the "thermal radiant feedback" in a fire to give us another sign of flashover. To the naked eye, we may not see fingers of fire or the heat build up. But with the Thermal Imaging Camera, you can. That is a tool that may save us. So many times in our lives, we can't see what all is going on inside us. Things look OK to us. We need some help in seeing.

The Psalmist prayed, In Psalms 139:23-24. "Search me O God and know my heart: test me and know my thoughts. See if there be any wicked way in me, and lead me in the way everlasting." The best way to find the fire raging inside us is to shed the light of God's way on our lives. All may look fine with the naked eye, and compared to others around us, but with the Light of God's Word we can find the fire within and recognize the signs of flashover in a fire and in life and you will live.

May God Bless you and keep you from "Flash-over"

Subcommittee Approves \$750 Million for FY 2004 FIRE Act Grant Program

WASHINGTON, DC -- The House Appropriations Committee on June 17, approved a \$29.4 billion fiscal 2004 Homeland Security appropriations bill by voice vote. The bill, one of 13 Congress must pass each year to fund the federal government and the first ever for the new department, would boost homeland security funding in the coming fiscal year, which begins on Oct. 1, by around \$1 billion more than the White House had requested. The Homeland Security Appropriations Subcommittee, chaired by Rep. Harold Rogers (R-KY), had approved the bill on June 12.

More specifically, the bill provides \$750 million for the Assistance to Firefighters Grant program. This is the same amount that was appropriated in FY 2003 and is \$250 million more than the President requested in his budget. Combined, all of the programs for first responders would be funded at \$4.4 billion under the bill, which is \$888 million more than Bush requested

Although a positive step, it is still very early in the process. The legislation must still be considered by the full House, go through the same process in the Senate before going to a Conference Committee and eventually to the President.

Highlights of the FY 2004 Homeland Security Appropriations Bill

- \$1.9 billion for the Office for Domestic Preparedness' basic formula grant program;
- \$500 million for state and local law enforcement terrorism prevention grants;
- \$500 million for high-threat, high-density urban areas;
- \$200 million Infrastructure Grants;
- \$750 million for Firefighter Grants;
- \$168 million for Emergency Management Performance Grants;
- \$35 million for a new competitive grant program for Centers for Emergency Preparedness;

- \$125 million for the National Domestic Preparedness Consortium: and
- \$134 million for technical assistance, national exercises, standards, and testing.

WASHINGTON, DC — Legislation that would expand the Public Safety Officers Benefits (PSOB) program to ensure that the families of more fallen firefighters, police, and EMS personnel are provided for is quickly gaining momentum in the U.S. House of Representatives and now has a majority of House members as cosponsors.

The Hometown Heroes Survivors Benefits Act (H.R. 919) would ensure that a public safety officer who suffers a fatal heart attack or stroke while on duty or not later than 24 hours after participating in a training exercise or responding to an emergency situation, is presumed to have died in the line of duty for purposes of public safety officer survivor benefits. The legislation was introduced by Representatives Bob Etheridge (D-NC), Steny Hoyer (D-MD), Michael Oxley (R-OH), and Curt Weldon (R-PA), has amassed an impressive 247 cosponsors.

The NVFC is now encouraging the fire service to contact their Representative and ask them to become a cosponsor of the Hometown Heroes Survivors Benefits Act (H.R. 919).

"The fire service needs to once again make their voice heard in Washington on this crucial issue." said NVFC Chairman Philip C. Stittleburg. "The only way to ensure that more families of fallen firefighters receive proper benefits when their loved ones fall while serving their community is to pick up the phone and call your Member of Congress."

The Public Safety Officers Benefits (PSOB) program currently provides a one-time death benefit payment of \$262,100, which is administered by the U.S. Department of Justice, to families of public safety officers (fire, police and EMS) killed in the line of duty, as well as to officers permanently disabled while on the job. The death benefit is payable to the survivors of a public safety officer who "has died as the direct and proximate result of a personal injury sustained in the line of duty."

Unfortunately, in almost every incidence of death by heart attack or stroke, it is ruled that the heart attack or stroke was not a direct result of an injury sustained in the line of duty and the family receives no benefits even though the deaths were clearly triggered by the rigors of the job. The Hometown Heroes Survivor Benefit Act would correct that deficiency in the law. Passage of this legislation is a priority for the NVFC and a wide array of fire, police and EMS organizations.

The Senate unanimously passed their version of the Hometown Heroes Survivors Benefits Act (S. 459) on May 16. The legislation was spearheaded in the Senate by Senators Patrick Leahy (D-VT), Lindsey Graham (R-SC), Susan Collins (R-ME) and Jim Jeffords (I-VT).

EMMITSBURG, MD. - The United States Fire Administration (USFA) announced the availability of a new document, Safe Operation of Fire Tankers. This new manual provides comprehensive information regarding the safety practices and principles of fire tanker vehicles for local-level fire departments. Safe Operation of Fire Tankers provides information related to human performance (driver training, operations, etc), technology (vehicle design), to enhance the safety of fire tanker operations. The manual also examines past incidents of crashes involving fire tankers that have killed firefighters with a focus on how these fatalities could have been prevented. Fire departments will find Safe Operation of Fire Tankers a valuable resource providing information related to the current and applicable Federal standards and regulations as well as national-level consensus standards and guidelines.

"Vehicle crashes are the second leading cause of all firefighter on duty fatalities," according to U.S. Fire Administrator R. David Paulison. "The USFA is dedicated to providing this information to the fire service in support of our desired goal to eliminate fire fighter deaths and injuries from fire tanker vehicle crashes."

As part of this project effort, a panel of technical experts in the area of fire service emergency vehicle operations, emergency vehicle maintenance, fire tanker design, and tanker water shuttle operations provided detailed recommendations on how to enhance the safety of fire tanker operations that were incorporated into the manual.

The newest addition to the departments fire fighting fleet is fully operational and ready for work. The construction process has been "long and tedious" according to Chief Johnson. Fire Boat One was designed and assembled by the members of this volunteer fire department in "Far Western Kentucky".

The craft is an 8 X 24 foot Alweld boat with a custom cab The craft is powered by a 200 HP Vindicator engine and has a top speed of 60 MPH. The fire pump is a CET 750 GPM pump with a top mounted deluge gun and both 21/2" and 11/2" discharges. The craft will be equipped for foam operations. Communications include a VHF radio to the local 911 center and a Marine band radio.

"Fire Boat One" will be housed at the main station house and will primarily respond via water, in a five mile radius of this location using local boat ramps near the station. The craft can be trailered to other locations if needed and requested.

Congratulations to Chief Johnson and all of the members of the East Marshall Fire Department on a job well done. This project has been ongoing for sometime now and I am sure that they are elated that it is completed. In addition, the East Marshall Fire Department now has a very much needed piece of firefighting apparatus that can be used to provide protection for the citizens and visitors in and around Marshall County.



Firebrick Fire Protection Dist.

Firebrick Fire Protection District (Lewis County) has taken delivery of a 2003 Central States 1250 GPM Pumper. The unit is mounted on a Freightliner M-2 Chassis with a MBE-900 300 HP engine and Allison Automatic transmission. A 1000-gallon UPF poly tank supplies the single stage Waterous pump.

The body features all roll-up doors, 26" deep compartments, shelving and mounting rails, in the upper section of compartments, for SCBA's and tool boards. A 2 1/2 " rear suction is provided for use in narrow roadway operations. 12 volt scene lights are provided on each side of the top mount pump panel. The pump panel is finished in black to eliminate glare and heat build up on bright sunny days.

On-Spot automatic tire chains were installed on the chassis. Because of the terrain of the district, automatic chains were a requirement. Roll-up doors were required because of the narrow streets and roads. Weldon lighting packages were specified for the apparatus.

The unit was sold by Fire Apparatus Division of S.D.C. of Louisville Kentucky.
