"Patient transports from a HAZMAT hot zone with All Terrain Res-Q Trailers"

While visiting with Chief Richard McGill of the North Vernon Fire and Rescue Department in southern Indiana last week, the chief came up with a great idea for patient removal from a HAZMAT hot zone, transport to the DECON site, and subsequent transfer to the EMS triage area. As the chief was checking out an All

Terrain Res-Q™ Trailer he observed this off-road patient transport system has an optional front swivel wheel. The "ATR Nose Gear" as it's called, allows for easy movement of the trailer when not hitched to an ATV or other tow vehicle. Almost immediately, the chief came up with the following scenario.

Two rescuers, and an All Terrain Res-Q[™] Trailer with the front swivel wheel in place, if outfitted with a mesh lined Stokes litter, could easily be used to transport a victim from a HAZMAT hot zone to the DECON site. Once there, the decontamination process could begin without the need to remove the patient from the litter or trailer. With it's open design, the patient, basket litter and rescue trailer would be decontaminated as one unit. After DECON, the trailer with patient still in the mesh Stokes litter, is rolled to EMS triage, removed from the trailer and awaits ambulance transport to a medical facility. As it has already been decontaminated, the rescue trailer is outfitted with another mesh basket litter and immediately returns to service for the next haul out from the hot zone. Using this system, which requires only two personnel per patient, an almost continuous victim removal process could be undertaken with a supply of mesh basket litters and All Terrain Res-Q[™] Trailers.





After hearing this common sense application of existing equipment, mesh type basket litters, in concert with new technology, All Terrain Res-Q™ Trailers, we felt it was important to share this with all ATR users. Also, so that others may benefit from the resourcefulness of this emergency service professional, PLEASE PASS THIS ALONG TO HAZMAT RESPONDERS IN YOUR COMMUNITIES. Wike Brady

What's UP with that?

The good thing about being semi retired is that I get time to read and ponder interesting issues. I want to try to pull together some seemingly unrelated issues that are really very much related.

In the summer issue of "Speaking of Fire" published by Fire Protection Publications of Oklahoma State University (you can view this document from a link on the KFA webpage www.kyfa.org), Kay Goss has written an article entitled "Emergency Management Handbook: The First of Its Kind". As the "Essentials Of Firefighting" has been to the fire service of the past the "Emergency Management Handbook" will be the future. The article introduces what I am sure will be a very significant book for the future of emergency services. In the article Ms Goss states.

"Emergency management is a highgrowth business and market. According to the most recent statistics from the U.S. Department of Homeland Security-Federal Emergency Management Agency (DHS-FEMA), over 130 institutions of higher education in the nation now offer degree or certificate programs in emergency management".

She goes on to state,

"Emergency management and homeland security are rapidly emerging professions with increasing challenges and escalating public and news media attention. Originally, there was one basic law regarding emergency management; now there are hundreds. A few rules and regulations were published in the *Federal Register* each year by FEMA; now there are hundreds published by numerous agencies and departments. Emergency management was handled by one congressional committee; now numerous congressional committees, commissions, and task forces deal with emergency management, its concepts, and homeland security.

The National Commission on Terrorist Attacks Upon the United States (commonly called the *9/11 Commission*) continues to issue accountability reports. Program baselines, strong guidance, and emerging standards are being designed, developed, and implemented to improve and institutionalize structures and capabilities. One of the first items of consideration in the current session of Congress, almost six years after the event, was the full implementation of *The 9/11 Commission Report* recommendations."

I spent a little time at a website called www.washingtonbudgetreport.com. This site is a good source if you are interested where our federal government spends our money. Our Federal Deficit (the difference between spending and revenues) for FY 2007 is \$344 Billion. We went from a 200+ Billion surplus in 2000 to a nearly 400 Billion deficit in 2004. Most of that difference was brought about by the events of 9/11. So as you can see the two subjects are very much related.

What does all of this have to do with you? If you as a fire service manager are going to stay in business, get your fair share of decreasing federal dollars, then you will need to become more of a emergency manager. I can remember like it was yesterday when Bill Hankinson, former director of of State Fire Rescue Training, say "Those boys are nothing but frustrated Bomb Shelter Wardens". Well the days of the old DES line of thinking are gone. We are now in the world of Homeland Security and it is in the driver's seat. Get on board or get left behind!

Milwaukee Cordless Tool **Battery Recall**

Batteries Used with Power Tools Recalled by Milwaukee Electric Tool Co. Due To Laceration Hazard

WASHINGTON, D.C. - The U.S. Consumer Product Safety Commission, in cooperation with the firm named below, today announced a voluntary recall of the following consumer product. Consumers should stop using recalled products immediately unless otherwise instructed.

Name of Product: Milwaukee Power Plus, Chicago Pneumatic, and Extractor 14.4 and 18 volt 2.4 Ah NiCd battery packs

Units: About 1 million

Manufacturer/Importer: Milwaukee Electric Tool

Co., of Brookfield, Wis.

Hazard: If a vent on the battery cell is damaged or compromised during use, the battery can explode and pose a laceration hazard to consumers.

Incidents/Injuries: Milwaukee Electric Tool Co. has received 35 reports of incidents, including 11 injuries from battery packs exploding while in use. Injuries include minor cuts, bruises and some hearing loss.

Description: The recalled batteries are used to power drills, saws, radios, flashlights, wrenches and Extractor windshield glass removers. The recall includes 14.4 and 18 volt 2.4 Ah NiCd Milwaukee Power Plus, Chicago Pneumatic, and Extractor battery packs manufactured between July 1999 and February 2004. The brand name can be found on a label on most battery packs. However, some 14.4 Volt 2.4Ah packs did not have "Power Plus" on the label. The battery packs were sold both with tool kits and as individual battery packs. Battery packs manufactured after February 2004 are not included in this recall.

Sold by: Home centers, hardware stores, industrial distributors and vehicle service distributors nationwide from July 1999 through 2005.

Manufactured in: Mexico

Remedy: Consumers should immediately stop using the recalled battery packs. Consumers should contact the Milwaukee Electric Tool Co. to determine if they have one of the recalled batteries. The company will provide a free replacement battery pack for consumers with recalled units.

FIREFIGHTER COMBAT CHALLENGE TO BE HELD IN LEXINGTON, KENTUCKY Aug 11-12, 2007

"Where's the Fire?" Will be the likely question heard wherever the Firefighter Combat Challenge is being held. Hundreds of firefighters organized by departmental teams and representing the best of the bravest, will battle head to head against themselves and the clock for high honors at the Challenge. The Combat Challenge will run in Lexington, Kentucky, near Rupp Arena, on August, 11-12, 2007.

What to expect - Wearing "full bunker gear" and a Scott breathing apparatus (SCBA), pairs of firefighters simulate the physical demands of real life firefighting by competing on a linked series of five tasks. Dominating the landscape is a five-story hydraulic tower, the centerpiece of all the activity. Competitors climb to the top of the tower carrying a 42-pound high-rise pack; then hoist a 42 lb. hose roll to the top; next they descend to the ground floor where they simulate chopping by swinging a 9-pound shot mallet on the end of a 160 pound steel beam. They then zigzag 140 feet through simulation hydrants to the fourth station, where they advance an attack hose a distance of 75 feet: and finally, competitors drag a life sized, 175 lb. "victim" a distance of 100 feet to the finish line.

Chaplain's Corner

Supporting Heroes

SUPPORTING HEROES is an organization that provides support to families of police, fire, and EMS heroes killed in the line of duty. Based in Louisville, Kentucky we serve ALL police officers, firefighters, and EMS workers in Indiana and Kentucky.

("Police," "fire," and "EMS" are general terms used to broadly categorize those who risk their lives for the "public safety" of our communities on a daily basis. Included are: police officers; sheriffs/deputy sheriffs; constables/deputy constables; sworn corrections personnel; firefighters; rescue squad personnel; EMS/ambulance personnel — including private ambulance personnel when they are engaged in municipal responses; etc.)

SUPPORTING HEROES is not an "insurance" program, but an "assurance" program. Our goal is to assure those who routinely risk their lives on the behalf of others that, should the ultimate call to service come, the loved ones they leave behind will be cared for — through a collaborative effort of their fellow public safety personnel and the citizens they served. Membership is NOT required to receive benefits. ALL public safety personnel in the two states are covered.

Our goal is to respond to all line of duty public safety deaths in Indiana and Kentucky and present a \$3,000 "emergency funds" check to the family within 24 hours. We then provide or facilitate additional support as needed/requested and as determined on a case by case basis. Additional immediate support can take many forms including, but not limited to: funeral planning/coordination; grief counseling; funeral travel assistance; home security; peer support; additional funds; etc.

Additionally, the members of SUPPORTING HEROES know that when a funeral is over, most people return to their normal lives. But for the survivors, "normal" will never be the same again. "A hero's sacrifice is forever" — so is the sacrifice of the hero's family.

Therefore, the care and support of SUPPORTING HEROES is long-term. A short time after the funeral, an assessment is made of the family's financial needs. As determined on a case by case


basis, monthly financial support is then provided to eliminate or prevent financial stress. The financial support continues until state and/or federal line of duty death benefits are received. Other forms of support are also provided — again, as determined on a case by case basis.

The members of SUPPORTING HEROES believe that when a public-safety professional routinely risks his/her life for his/her community then ultimately makes the supreme sacrifice, the community and public safety family should "carry on" on his/her behalf and look after the loved ones left behind. We want to do that in grand fashion and, while doing so, demonstrate to the survivors that what their loved one lived and died for is important, people remember, and they care.

Individual membership is \$120 per year. Family membership (2 adults) is \$200 per year. There is no charge for public safety survivors for membership. Dues can be paid annually, semi-annually, quarterly, or through monthly credit card drafts. NVFC Calls For Department of Justice to Award Hometown Heroes Claims

Calls For Congressional Investigation Into the Award-Making Process

At a press event today in Washington, DC, the National Volunteer Fire Council (NVFC) called for the Department of Justice (DoJ) to begin awarding Public Safety Officer's Benefits (PSOB) to families who applied for the benefit under the Hometown Heroes Survivors Benefits Act. PSOB is a one-time payment of nearly \$300,000 to the families of fallen public safety officers. The Hometown Heroes Act, which became law in 2003, was supposed to make it possible for public safety officers who die from heart attack or stroke caused by participation in emergency response to qualify for PSOB. Since passage of the law, DoJ has made seven awards, denied 47 claims and has 199 claims that are still pending.

"From the language of the law to the clearly expressed intent of Congress, DoJ should be paying benefits in cases where a public safety officer died from heart attack or stroke within 24 hours of participating in emergency response," said NVFC Chairman Philip C. Stittleburg. "DoJ needs to start making these payments today, and Congress should investigate why three and a half years after passage of the law so few payments have been made and so many denials and pending cases exist."

The press conference took place in the Dirksen Senate Office Building. Also speaking were Senator Patrick Leahy (D-VT), Congressmen Bob Etheridge (D-NC), Dave Reichert (R-WA), and Spencer Bachus (R-AL). The widows of three fallen firefighters and representatives from other public safety organizations also spoke.

DoJ has denied claims in which firefighters suffered a fatal heart attack during emergency response. Their justification is that emergency response doesn't necessarily constitute "nonroutine stressful or strenuous physical" activity. A report that appeared recently in the New England Journal of Medicine would appear to contradict this, finding that firefighters are at an extremely heightened risk of suffering a heart attack not only during fire suppression but during alarm response and alarm return as well.

"I've got a news flash for DoJ," said Stittleburg. "Emergency response by its very nature *is* nonroutine stressful and strenuous physical activity. Ask anyone who actually knows what it is like to respond to an incident and they'll agree with me."

"DoJ has been determining on a case-by-case basis whether or not the emergency response described in a PSOB application passes some illusory litmus test," Stittleburg continued. "This puts tremendous pressure on public safety agencies to create a detailed narrative of the deceased officer's activities that accurately conveys the physical and emotional strain of emergency response."
