July 30, 2011

<u>Resolution #4</u> resolved jointly between KFC & KBEMS hold their mutual interest in delivery of quality EMS form a working group under administrative control of KBEMS, and work towards adoption of alternative assessment tool for students seeking certification in addition to the National Registry examination. Resolution #4 was unanimously sent to the EMS committee by voice vote.

<u>Resolution #5</u> resolved to support and assist EMA's efforts to pass legislation that would help clarify issues relating to mutual aid across state lines. Resolution #5 was unanimously sent to the legislative committee by voice vote.

August 2, 2011
