### Scott Firefighter Combat Challenge Lexington Kentucky 8/14-15/2009

Things are at a fevered pitch as teams register for the Scott Firefighter Combat Challenge in Lexington Ken-

tucky on August 14-15. The Scott Firefighter Combat Challenge brings together hundreds of firefighters from throughout the nation to compete in what is known as "the toughest two minutes in sports." The five-event obstacle course tests firefighter's fitness level, agility, and heart. This event celebrates the excellence of America's beloved heroes. The Challenge seeks to encourage firefighter fitness and demonstrate the profession's rigors to the public. Wearing "full bunker gear" and breathing apparatus, pairs of competitors race head-to-head as they simulate the physical demands of real-life



firefighting by performing a linked series of five tasks including climbing the 5-story tower, hoisting, chopping, dragging hoses and rescuing a life-sized, 175 lb. "victim" as they race against themselves, their opponent and the clock. At the penning of this article there are 12 teams signed up for Friday the 14<sup>th</sup> and 6 teams signed up for Saturday the 15<sup>th</sup>. Don't miss this wonderful opportunity to see a world class event right in your own back yard. The competition will be held in the parking lot behind Rupp Arena in Lexington where also there will be a welcome party Friday evening.

The last time the competition was held in Kentucky was the 11 & 12 of August 2007. This time Kentucky competitors will know more of what to expect. It's not easy and not called the "the toughest two minutes in sports" for nothing. If you have never seen this exciting challenge before you will certainly want to put this on your to-do list for August 14<sup>th</sup> & 15<sup>th</sup>. The finals for world bragging rights will be held in Las Vegas in November from the 16<sup>th</sup> to the 20<sup>th</sup> and is usually carried on ESPN.

### NFPA announces theme for Fire Prevention Week 2009

Each October since 1922, the National Fire Protection Association (NFPA) has sponsored a fire prevention campaign to raise awareness about the importance of fire safety and fire safety education. Fire Prevention Week is October 4-10, 2009 and today NFPA announced its theme: <u>Stay Fire Smart! Don't Get Burned</u>.

U.S. fire departments responded to 399,000 home fires in 2007. These home fires killed almost 2,900 - roughly eight people every day.

This year's fire prevention campaign, <u>Stay Fire Smart! Don't Get Burned</u> focuses on ways to prevent fires, and the deaths, injuries, and property loss they cause. Eighty-four percent of all fire deaths were attributed to a home fire. By providing valuable information on fire and burn prevention and safety tips, the campaign aims to help the public keep their homes and its occupants safe from fire and burns.

Fire Prevention Week commemorates the Great Chicago Fire of 1871. That fire, which lasted for two days, killed more than 250 people, left 100,000 people homeless, and destroyed more than 17,000 buildings.

NFPA's newly launched Fire Prevention Week Web site offers an abundance of safety tips, statistical information, and other resources that can be used by fire departments, teachers, families, and anyone else interested in learning about fire prevention or teaching others about it.

Leading causes of fires in the home include cooking, heating, and electrical. Smoking is the leading cause of home fire deaths. The leading injuries resulting from fires in the home are burns. Burns are painful and can result in serious scarring and even death. The most common types of burn are contact burns, scalds, and burns from fire or flame.

Someone was injured in a home fire every 39 minutes in 2007 and a fire department responded to a home fire every 70 seconds. By implementing simple safety measures many home fires and home fire injuries can be prevented.

NFPA has been a worldwide leader in providing fire, electrical, building, and life safety to the public since 1896. The mission of the international nonprofit organization is to reduce the worldwide burden of fire and other hazards on the quality of life by providing and advocating consensus codes and standards, research, training, and education. ### The Federal Highway Administration adopts an Interim Final Rule

The FHWA adopts as final an Interim Final Rule that amends its regulations to address safety concerns raised by the firefighting community regarding high-visibility safety apparel. The purpose of adopting the Interim Final Rule as final is to reflect the exemption of firefighters from the requirement to use high-visibility safety apparel, as defined in this rule, when they are exposed to hazardous conditions where the use of such apparel may increase the risk of injury to firefighter personnel.

This ruling will allow firefighters to use turnout gear with appropriate retro reflective bands when the possibility of fire/hazmat is present.

#### THE COURAGE TO BE SAFE

This month's topic, within the "16 Fire Fighter Life Safety Initiatives", looks into "Risk Management." Risk Management is the rapidly growing technique of reducing and/or preventing monetary loss, personal injury and/or death by assessing, minimizing, and preventing behavior that leads to these situations. Simply put, we need to look for, identify and prevent behavior that might lead to firefighter injury or death.

# #3-"FOCUS GREATER ATTENTION ON THE INTEGRATION OF RISK MANAGEMENT WITHIN INCIDENT MANAGEMENT AT ALL LEVELS, INCLUDING STRATEGIC, TACTICAL AND PLANNING RESPONSIBLITIES."

**Strategy** is broadly defined as a plan of action and **Tactics** as the implementation of that plan. **Planning**, on the other hand, can be defined as our department policies, rules and regulations and Standard Operating Guidelines or Procedures. So, how do we incorporate Risk Management into these three areas? Let's use an example of a structure fire in the bedroom of a single family dwelling with occupancy unknown.

- **-Our Strategies may look something like:** 1) Perform search and rescue; 2) Extinguish the fire; 3) Overhaul the area of fire involvement.
- **-Our Tactics may look something like:** 1) Send in a search crew; 2) Advance a hose line; 3) Pull the walls and ceilings

What is missing here? What needs to be considered when forming any strategic plan or tactically operation on a fire ground? None of the strategies or tactics mentions anything about safety. Many firefighters are injured and killed each year because their safety is not a primary consideration during these phases. There are real risks associated with all of these tasks. A major challenge for the Incident Commanders is to assure that all of these tasks are planned and performed however; they must be performed in a safe manner. Your

strategies must take into consideration the safety of your firefighters. Carrying out tactics must include consideration for the safety of your firefighters. So let's take a look at this residential fire scenario in a slightly different way:

# 1) Perform search and rescue? Are we sure we have victims? Based on our length of response and fire conditions are they viable? Based on current fire conditions what are the chances of a suc-

Our strategies should look something like:

and fire conditions are they viable? Based on current fire conditions what are the chances of a successful rescue? 2) Extinguish the fire? Is the building salvageable? Is what you might save really worth putting someone inside? 3) Overhaul the area of fire involvement. Is the building structurally safe to enter? Is the structure sufficiently clear of smoke and deadly gases to safely enter?

Our Tactics should look something like: 1) Send in a search crew; who are well trained in search and rescue, with a Thermal Imager 2) Advance a hose line; of the right size and flow, charged before entering, through an opening at or below the level of the fire; 3) Pull the walls and ceilings; After the structure has been determined to be stable, and after the smoke is clear and the inside air is monitored to assure there are no remaining toxic gases.

So with just a few additional thoughts, the Incident Commander can incorporate safety into his/her strategies and tactics. It's as easy as that.

The final level of Risk Management to be addressed is "Planning". Can we plan to be safe? Absolutely. In previous articles, the importance of written rules and regulations and SOG's/SOP's has been stated. If basic strategies and tactics are part of your policies, there will be less risk on the fire ground and a much better probability that your fire-fighters will perform safely thus, keeping them alive and well.

Perhaps the easiest way to incorporate the thoughts of Risk Management into your everyday operations is to simply put at the word "Safely" at the beginning of every strategic plan, tactical operation, SOG, SOP, and any tasks that you wish to accomplish. For example, "Safely back the engine up the street" or "Safely, advance the hose into the house." This will help assure that each of us, "Keeps Going Home, After Each Run and After Each Shift."

Each time you take the written test you must pay a \$15.00 charge. Contact Duane Suttles for more information about written test location and dates at 888-301-2946. REMINDER: Candidates must be at least 18 years of age and be a member of a Kentucky FD or a full-time student of Fire Science at EKU or KCTCS to be eligible for firefighter testing. Candidates must bring state issued drivers license or ID card to skills testing site for positive identification and verification of age eligibility. Candidates under 18, may complete any of the written exams, and may certify to Haz Mat Awareness only. All Certifications are based on the Professional Qualification standards set forth by the NFPA for Firefighters, except Haz Mat, which is a Job Performance standard. Our accreditation is through the International Fire Service Accreditation Congress (IFSAC).

### Major Funding Cut for AFG Moving Forward in House and Senate

The House and Senate versions of the FY 2010 Department of Homeland Security (DHS) Appropriations Act both contain sizable reductions in funding for the Assistance to Firefighters Grant (AFG) program. Both the House-passed bill (H.R. 2892) and Senate-passed bill (S. 1298) would provide \$390 million in funding for AFG – a \$175 million decrease from FY 2009. Both bills provide \$420 million for the Staffing for Adequate Fire and Emergency Response (SAFER) grant program, a 100 percent increase from last year.

AFG and SAFER provide funding through a direct, competitive grant process that incorporates fire service input at every step along the way, from criteria development to peer review of applications. AFG primarily provides funds to help local agencies purchase equipment, training, and apparatus. SAFER grants are used to hire career firefighters, with 10 percent set aside to assist local fire departments with recruitment and retention efforts.

President Obama's FY 2010 budget request proposed reducing funds for AFG by 70 percent, from \$565 million to \$170 million. In subsequent Congressional hearings on the budget request, DHS Secretary Janet Napolitano gave two primary justifications for cutting AFG so drastically: \$210 million had been made available to the fire service in the form of fire station construction funding in economic stimulus legislation that passed earlier in 2009, and funds were shifted from AFG to SAFER in order to help career fire departments avoid layoffs.

The House and Senate Appropriations Committees restored \$210 million in funding from the President's budget but complied with the President's proposal to shift funds from AFG to SAFER. An amendment increasing funding for AFG from \$380 million to \$390 million was adopted when the FY 2010 DHS Appropriations Act was considered by the full House of Representatives. The House Rules Committee blocked three other amendments increasing funding for AFG by \$20 million, \$30 million, and \$40 million respectively,

from ever being offered. The National Volunteer Fire Council (NVFC) had worked closely with Congressmen Bill Pascrell (D-NJ), Peter King (R-NY), and Steve Austria (R-OH) in developing the \$40 million amendment. The \$20 million amendment was offered by Congresswoman Judy Biggert (R-IL), and the \$30 million amendment was offered by Congressman Jason Altmire (D-PA).

The NVFC worked with Senators Bernie Sanders (D-VT) and Robert Casey (D-PA), who offered an amendment to increase funding for both AFG and SAFER by \$50 million during consideration of S. 1298. The amendment was defeated in floor vote by the full Senate, but another amendment offered by Senator Chris Dodd (D-CT) was adopted increasing funding for AFG by \$10 million.

With the DHS Appropriations having passed the House and Senate, the bill will now go to a conference committee, where differences between the two versions will be sorted out. Since the House and Senate funding levels for AFG and SAFER are the same (\$390 million and \$420 million, respectively) it is likely that they will not be changed in the conference committee report.

ing new commission members Brigadier General John W. Heltzel, Executive Director of Kentucky Emergency Management, and Dave Goldsmith, Chief of Highview Fire District (see picture below).



At that meeting there was also a Ribbon Cutting Ceremony for the new Training Tower located at the Clear Creek Station.

In the center of the photo at the top of the next page is Fire Commission member Kevin Williams and Fire Commission Chairman James Riddle. Members of the department were very appreciative of their new training tower and the possibilaties the new facilities give them for better training.



The Fire Commission's new fire training system is up and running. The old system will be shut down as of August 1, 2009. All fire departments will need to apply for a new User ID and Password. ### **Public Officials Liability**

Why is it needed for Fire Service Personnel? By William R. Dixon, Director of Marketing Emergency Services Insurance Program

Some Fire Service personnel may have misconceptions regarding how they are covered in their capacity as directors and/or officers. They may think it is covered under the department or district's liability policy or under a personal "Umbrella" policy they may have purchased individually. However, if they are not carrying specific coverage for Public Officials they may be underinsured. Most personal Umbrella policies are written by insurance companies which design coverage to exclude the decisions and/or acts made while acting as a Director or Officer of any organization, particularly a public entity. General Liability policies don't always address the "Errors and Omissions" exposure which is where specific coverage for individuals (including Directors and Officers) against claims arising out of any acts, errors and ommissions can be found.

How can a Fire Department or Fire District protect itself? Why should it consider protection? The best and most common vehicle for this protection

is Public Officials Liability coverage. Some reasons for considering this protection are outlined more specifically below.

A well-written Public Officials Liability policy will cover the Fire Department or District and its past, present and future Directors and Officers, Board Members, committee members and volunteers for acts, errors and omissions of many kinds (subject to the specific exclusions of the policy).

One of the primary purposes of this coverage is to provide legal defense against claims and suits alleging wrongdoing resulting in monetary damages (but not including bodily injury or property damage-which are covered by the General Liability policy). A good example would be a Fire District that was repeatedly hauled into court by a "claimant from hell" whose claims involving his "right" to use the District's property were groundless. While no judgment or settlement was ever made or offered, it cost plenty of money to defend.

Other areas we have seen trouble for Fire Departments and Districts is Sexual Harassment and Employee Practices, including wrongful termination. This would also include actions taken against volunteers. Make sure your policy does not specifically exclude these coverages. Recently we have seen a trend by many insurance companies to attempt to exclude these volatile areas.

There are, of course, areas where coverage is not going to be given. Claims involving pollution won't be covered (they may be picked up by a specific endorsement to the General Liability Policy). Claims involving fraud are not covered if fraud is proven, however the Fire Department or District and individuals innocent of alleged fraud will be protected. Claims demanding either a specific action or cessation of an action are not covered unless there is specific coverage for Injunctive Relief or Non-Monetary Damages. Check your policy for specific wording.

Costs for this coverage vary depending on the size and activities of the Fire Department or District. For a small department premiums may start as low as \$500. You may even find a company that will include the cost in the General Liability policy. The limits sold are usually with a \$1,000,000 per occurrence limit. Sometimes you can find a company with an unlimited aggregate, the most which will be paid during a single policy term, but most cap the aggregate at \$2-3 million.
