- Fee based on budget; \$0 \$100,000.00 = \$25, \$100,001.00 \$500,000.00 = \$250, \$500,001 and above = \$500
- There will be a help website up and running soon. When it goes Live Mike Kurtsinger will notify everyone.

- Fire deaths for the first quarter are 35. This number is too high.
- Hosted a round table discussion concerning fire prevention with many different agencies and organizations
- Fire prevention is critical and there is a need to develop a comprehensive plan
- Kentucky Fire Fatality Task Force has been established to create a comprehensive program. Working with an organization out of the northwest called Vision 20/20
- Fire Safe Community is the name of the program and it calls for departments to do risk assessments in the community and challenges departments to do home safety surveys, smoke detector installation program, and to use your pub ed component in other areas of your community not just in the schools.
- Could possibly have impact on ISO ratings
- Anyone interested in joining group is invited
- Hope to roll out program in October
- Sprinklers in beginning of adoption of building code, sprinklers were a part of this code, it stalled in legislation due to many questions unanswered, still working on getting it implemented in the building code.
