KFA Executive Director- Randy Lawson

Its good to see everyone. The last two years have been quite an adventure.

I filed my report with the Secretary but will hit the highlights.

I have been working with the President answering calls attending meetings.

I have attended all E-Board meetings.

Attended 8 funerals during the past two years.

Worked with Howdy Kurtsinger and Joe Bear on Legislative issues.

Lately I have been fielding a lot of calls on soliciting. The KFA does not solicit money by phone. If another fire organization is I usually know about it but at this time I am not aware of any.

Fire Commission- Bruce Roberts

The project at the National Responder Preparedness center is on hold and will start back up some portions will have to be rebid.

Grants- If your department received a PPE grant the receipt and cancelled check are due. We are looking to open up a new PPE grant and before you can apply your previous grant must be closed out.

The Fire Commission office is undergoing reorganization it is anticipated in October/ November we will be posting 8 to 9 open positions.

Kentucky Fire Commission – State Fire Rescue Training Director of Training Report

Kentucky Firefighters Association Conference 2021 FY21 was an unusual year with the COVID 19 pandemic. We worked to continue to present training utilizing a variety of delivery methods when requested. Our instructors delivered training to 659 of the 779 fire departments in the Commonwealth which was 84.6% of the departments. We presented 5489 classes totaling 22608.5 hours to 74,856 students. 80.67% of classes delivered were fire topics and 85.67% of our total students were fire classes. Of the fire classes that were delivered 449 of them were taught utilizing the Virtual Instructor Led Training platform via Zoom. State Fire Rescue Training has had some personnel changes over the last few months. In July Kacie Mills joined us as the Area 7 Field Office Coordinator. Area 5 Coordinator Rusty Todd transitioned from full time to part time instructor on April 30. John Gentry began as the new Area 5 Coordinator on August 1. John has vast history with volunteer and career fire departments most recently retiring from Lexington Fire. Charlie Lott retired as the Area 2 Coordinator on June 30. Charlie served the fire service in the Commonwealth for many years. We currently have an active job posting for the Area 2 Coordinator in Princeton. Larrel Alley (LA) transitioned from full time to part time instructor on June 30. The Accredited Certification Coordinator should be announced soon as we have conducted the interview session for that position. Shannon Mason Jones resigned as the SFRT Area 12 Field Office Coordinator and that position will be posted in the future. Margaret Melton has announced her retirement effective August 17 and that position will also post in the future. There will also be another Coordinator that will be transitioning from full time to part time instructor within the next few weeks. Also, with the reorganization plan that has been put into place by Executive Director Larry Potter, SFRT will be having two Regional Directors. Interviews for one of those positions has occurred and we will interview for the other position soon. As a result of the reorganization and resignations/retirements, SFRT will be hiring for several positions within the next few months.

SFRT Area Coordinators area reaching out to all fire departments to schedule training for FY22. We will be able to provide 21 hours of instructor led training to your department. Each area has some additional funding available for training at regional fire schools and/or larger, area wide training courses. We have courses/topics to offer every department in the Commonwealth regardless of the department's size. Check on the Fire Commission's website for a course catalogue to assist with planning your annual training request.

Our Accredited Certification office has been busy adding new levels. We have added Live Fire Instructor and Live Fire Instructor In Charge, both of which follow NFPA 1041. We are currently working to add a certification which will meet NFPA 2400: Standard for Small Unmanned Aircraft Systems Used for Public Safety Operations. Our first group of instructors will complete the train the trainer (TtT) and testing for this level during the last week of August. We will be sending that information to IFSAC for an administrative review so that we can offer this certification. We are working to add several certifications detailed in NFPA 1006 Standard for Technical Rescue Personnel Professional Qualifications. We anticipate updating several levels this fall to the new editions of the respective standards, including NFPA 1021 Fire Officer I and II, NFPA 1002 Driver Operator, D/O Pumper, D/O Aerial, and Mobile Water Supply. Our anticipated transition will be on January 1, 2022 and we will provide advance notification.

This is reminder that SFRT manages the AAS Fire Science Technology degree that is offered at several of the KCTCS colleges. The degree is structured to accommodate both new, traditional students that attend classes on campus for four semesters and for non-traditional students that may strive to use work experience and certifications to receive course credit while working full time and desiring to achieve a college degree for career advancement. Firefighters currently working may be closer to a degree than they would expect so contact your SFRT Area office for more information.

Kentucky Professional Fire Fighters- Joe Bear

Congratulations President Beatsch on a good conference. I am glad we have such a good working relationship. The KFA and KPFF are hard at work in Frankfort for our firefighters. We will continue to improve the Cancer Bill and PTSD bill. On the federal level looking to pass legislation to expand Medicare for Firefighters that have retired.

The KPFF, KFA and Fire Commission need ot come up with a hotline for Members that are struggling with mental health issues. Also the legislation we passed on reimburse members out of pocket expenses with treatment costs. If you are being treated contact Fire Commission on how to get the process started.

State Fire Marshall- Mike Haney

We have sent to the Legislative Research Commission our request to adopt the 2018 Life Safety Code, and the 2018 Fire Code. We currently use the 2012 of these code books. We believe we will be allowed to go forward with this request but ask for the KFA to support our bid for approval.

The FM's office is in the process of hiring 3 Deputy State Fire Marshals, 1 Hazardous Materials Inspector, and 1 Hazardous Materials Section Administrative Assistant. We have had 2 retirements, and 2 resignations in the past month and need to fill those positions as quickly as possible.

Our Office will be working the State Fair Detail for the next several weeks. From set up to close, our office will be working t ensure the safety of the attendees of the fair.

COVID 19 cases are on the rise reminding us that this pandemic is far from over. Now, it is more important than ever to protect yourself and others. Please get vaccinated if you have not done so already. While it is not a 100% guarantee to prevent contracting the virus, it is 90% plus in preventing serious illness, hospitalization, and death. Your best defense is vaccination. Honor Guard- Charlie Rafferty

Since our last conference the Honor Guard responded on two funeral details the first was Woodrow "Woody" Will, and second Calloway County Fire-Rescue Assistant Chief Timmy Manning.

At the beginning of the COVID-19 pandemic lockdown gave us time to focus on the Honor Guard trailer. The equipment trailer was initially set up with work bench style shelving on both sides with the flags being at the end of each shelf area held in place with bungee cords. This caused wrinkling of the flags. At one point, while the cord was unhooked to remove the flags to be used, one fell causing the topper to brake. At times several members would be in the trailer dressing at off-site locations and due to the previous set up space was tight. To better suit our needs a reconfiguration was needed. So as most of you have hopefully seen, in the May 2020 edition of Smoke Signals II, the trailer got a makeover. The closet for uniform storage stayed, but all of the shelving was removed. New shelving was installed down one side, and a bench style seat with flag, and flag base storage under the seat area on the other side. This will help keep wrinkling of the flags down. New LED lighting was installed, replacing the old compartment lights from an ambulance, that were originally installed. The two sets of parade axes, and pike poles were in the original cardboard boxes that were coming apart so hard sided foam padded plastic rifle cases were ordered to better protect those as well. The interior and floor were painted to knock down on the dust in the trailer. All in all, it took about two weeks, time to complete this project. I would like to thank Honor Guard member Al Wathen, and VP Marc Henderson, with The National Responder Preparedness Center in Greenville Kentucky for all of the work and space to make this happen.

On the KFA web site the Honor Guard section has been updated to include photos of the Honor Guard at the National Memorial, and State Memorial services. As well as information on Mission or Purpose of the Honor Guard, Member Qualifications, and Honor Guard Activation.

It seemed fitting to debut the new uniforms here at the 100th conference although they aren't the same style as before we will be able to accommodate several personal in each uniform whereas before with the custom-tailored coats. Rain covers for the hats all weather coats, and raincoats have also been added to the inventory to help keep the new uniforms looking good.
