## Lake Dreamland Fire Department Looses a beloved Chief and friend!



Chief Wilkinson suffered a fatal heart attack at his home early on the morning of April 13, 2012 after returning from a fire call. He was 44 years old and had served as a Lake Dreamland firefighter since 1985. He advanced to Chief in October 2010 when his father retired after serving the department for fifty years. Chief Wilkinson was also Assistant Chief of Kentucky Air National Guard Fire & Rescue where he has also served since 1989.

Chief Wilkinson was a third-generation Lake Dreamland firefighter. His grandfather was killed in the line of duty in 1950 when he fell from a responding apparatus.

He is survived by his wife Jennifer, daughter Shianne, and mother Nancy.

On April 26, 2012 Secretary Monica Rath and I, along with members of the fire commission, fire chiefs association, professional firefighters association and homeland security traveled to our nation's capital of Washington, DC. While in Washington we met with several of our congressman and our senators to discuss with them the need for continued support of legislation for the overall good of the fire service.

During our meetings we discussed the following legislation with them:

- S.911 Public Safety Spectrum and Wireless Innovation Act this would open up the interoperable wireless broadband network.
- S.550/HR 2269 this act would fully fund the assistance to firefighters grant program and the staffing for adequate fire and emergency response grant program through 2016.

- HR 376/S.1911 Volunteer Emergency Services Recruitment and Retention Act this act would amend the IRS code to allow for length of service awards for volunteer firefighters.
- HR 1792/S. 1035 Fire Sprinkler incentive Act
- Chief Possich discussed regeneration issues on diesel engines which raises the cost of new fire engines and could endanger the lives of firefighters and citizens. The request would be for the EPA to waive fire trucks from this requirement beginning in 2013.
- Chief Shuck discussed issues related to receiving surplus property from the military.

This was a very successful trip and our legislators understand the need for support of the fire service in Kentucky.

### 2012 E. James Monihan Director of the Year: Ken Knipper



Ken Knipper has been awarded the E. James Monihan Director of the Year award by the National Volunteer Fire Council at the NVFC Spring meeting. Ken was recognized for being a tireless voice and advocate on behalf of the emergency medical services and has dedicated over 30 years

### **NVFC Committee Report**

The Spring Board Meeting was held in Washington, DC on April 26-29. Bryant and I attended with 35 other states being represented. A major administrative issue was the development and approval of a three-year strategic plan.

Before the meeting I was privileged to represent the NVFC on a CFSI panel regarding the im-

pact of the EMS Bill, a discussion on the NEMSAC Roundtable on the EMS Education Agenda for the Future, and the impact of private sector EMS acquisitions, mergers, etc. Phil Stitleburg, NVFC Chairman, participated in a discussion on transition to combination departments. It was interesting to note that a few full paid department chiefs were also being asked to transition to combinations departments. These are interesting times.

As usual many legislative issues were discussed and priorities set. There are a number of important legislative initiatives to follow so instead of numbering the priorities as they have done in the past the legislative committee agreed to use a monitoring system to keep abreast of the various bills. The system provides three levels of monitoring.

The EMS/Rescue Section continues to develop and completed a strategic plan for the Section. The main emphasis behind the plan is to grow the Section. New promotional materials will be developed to show the benefit of membership and participation in the Section. Information can be obtained by going to [www.nvfc.org](http://www.nvfc.org) and checking the EMS section.

The NFPA is currently soliciting input on a project on Community Paramedic Programs. The NFPA Technical Committee on EMS has received requests to develop a guidance product as there is little information available for those who are considering such a program. If you feel such an effort is justified, write the NFPA, 1 Batterymarch Park, Quincy, MA 02169-7471. These programs are growing around the country with Wisconsin being the first state to pass enabling legislation for such programs.

The NVFC has just released a Junior Firefighter Recruitment Program video. Check the NVFC site [www.nvfc.org/juniors](http://www.nvfc.org/juniors) to download the video.

The NVFC also has on line an Emergency Services Liability program. This program was developed with Chief Bill Jenaway and VFIS. It is an outstanding program that covers many emergency responder liability issues.

Bryant Stiles is working with a group on the development of a B.E.S.T Incident Safety Officer Course. This project is funded by Motorola through the FEMA Grants Office.

If you intend to attend any Fire Academy or FEMA courses you will need to obtain an ID number from FEMA as they will no longer be using social security numbers.

I had previously sent notice regarding a program by Globe Uniform to supply free turnout gear to volunteer departments. Go to [www.nvfc.org](http://www.nvfc.org) and check the Globe application process.

Get on your computer and go to [www.nvfc.org](http://www.nvfc.org) and pull up the 2011 annual report. If you want to learn more about the NVFC and what it does for volunteer firefighters every day, take a look at this issue. Browse the site as it is filled with valuable information.

## FIRE DEPARTMENTS HOLD RECOGNITION SERVICE

Two all-volunteer departments headquartered in New Haven KY, the New Haven and Rolling Fork Fire Departments, held a service of recognition and blessings on Thursday, May 10 at the departments' station on Center Street in New Haven. The two departments respectively provide fire protection and rescue to the City of New Haven, and a rural area of approximately 100 square miles in southern Nelson and northern Larue counties.

This opportunity to honor the all-volunteer membership of the two departments coincided with the observance of the feast day for St. Florian, patron saint of firefighters, according to the Rev. Troy Overton, Administrator of St. Catherine Roman Catholic Church, New Haven and Immaculate Conception Roman Catholic Church, Culvertown, both in the two departments' service area. "We had wanted to find a way to recognize the good work of these two departments, since we are all part of the same community," he noted. "I met with the chiefs of both departments and their chaplain, the Rev. Karl Lusk, Pastor of the Episcopal Church of the Ascension, Bardstown, who lives in New Haven. They were very receptive to the idea."

The service, led by Frs. Overton and Lusk, offered prayers to ask God's blessing on the fire apparatus, equipment, and building, as well as the firefighters themselves. A St. Florian medal was presented to each firefighter. About sixty members of the public attended, in addition to twenty-two members of the two departments and representatives of the Bardstown-Nelson County Fire Department and Boston Fire Department. "We really appreciated the community turn out to support our firefighters," Lusk said. "We hope to make this an annual event to honor those who give countless hours in training, responses, and community service."

St. Florian was a Roman soldier who headed a unit of the Roman Army specially trained in fire-fighting, stationed in what is now Austria. They were assigned to protect government buildings in case of fire and were one of the first recorded

Written testing information is available on the Ky IFSAC testing web site at <http://www.kyffcert.com>. Tests are given at the system office usually on the third Monday of the month. Each time you take the written test you must pay a \$15.00 charge. Contact Duane Suttles for more information about written test location and dates at 888-301-2946. REMINDER: Candidates must be at least 18 years of age and be a member of a Kentucky FD or a full-time student of Fire Science at EKU or KCTCS to be eligible for firefighter testing. Candidates must bring state issued drivers license or ID card to skills testing site for positive identification and verification of age eligibility. Candidates under 18, may complete any of the written exams, and may certify to Haz Mat Awareness only. All Certifications are based on the Professional Qualification standards set forth by the NFPA for Firefighters, except Haz Mat, which is a Job Performance standard. Our accreditation is through the International Fire Service Accreditation Congress (IFSAC).

## EDUCATIONAL CORNER

### *When a Firefighter is Expecting*

I was 29 years old when I walked into my local fire department and asked for a membership application. The officer that met me at the door asked, "For you?" While I thought the answer to that question seemed obvious as I was the one asking, I soon realized that women in the fire service face several challenges I didn't expect. Fortunately, feeling accepted was never an issue in my department; the men I work with have always been supportive and encouraging. What I did not anticipate was turn-out gear that never fit me right because it was designed for a man's body, boots that were almost always too big, learning to do the same job differently using body mechanic techniques to compensate for my weaker upper body, and figuring out how to handle bathroom issues when on long calls.

According to the International Association of Women in Fire & Emergency Services, nearly 35-40,000 women volunteer as firefighters and 6,200 women currently work as full-time, career fire-fighters and officers in the United States. The conversation stopper in many board rooms then becomes what should we do if a female firefighter becomes pregnant. Is she able to continue active duty? Can she still be a member of the fire department? Every department, whether career or volunteer, should develop policies regarding short-term medical disabilities, including pregnancy and reproductive health, to ensure that all personnel are treated fairly and without discrimination. To do this, emergency service organizations should educate themselves on the legalities pertinent to pregnant firefighters and EMS personnel, develop policies that will address leaves of absence, light duty or non-hazardous alternatives, training and personal protective equipment.

One Federal Statute and two court decisions have helped to provide guidelines for emergency service organizations that are developing policies surrounding pregnancy. The Pregnancy Discrimination Act of 1978 (PDA), and amendment to the Title VII of the Civil Rights Act of 1964, broadens the definition of sex discrimination set forth under Title VII to include discrimination based on pregnancy and childbirth. In summary, this change

makes it necessary for organizations to treat pregnancy related medical conditions the same as any other disability condition that affects a members ability to perform specific duties associated with their position within the organization. In 1987 the Supreme Court's decision on California Federal Savings and Loan, directed that employ-ers must do for the pregnant worker at least as much as they do for the worker who is injured off the job. In 1991, Supreme Court addressed fetal protection policies in its decision in UAW v Johnson Controls. Johnson controls had barred all fertile women from working in jobs using lead be-cause lead could harm a fetus. The Supreme Court reflected this policy as a form of sex discrimination and a violation of the PDA. The majority opinion stated, "Decisions about the welfare of future children must be left to the parents who conceive, bear, support, and raise them rather than the employers who hire those parents... It is no more appropriate for the courts than it is for individual employers to decide whether a woman's reproductive role is more important to herself and her family than her economic role. Congress has left this choice to the woman as hers to make." Ultimately the decision to transfer to light duty or take a leave of absence from the department cannot be mandatory.

With these guidelines in mind, an organization needs to establish procedures for notifying appropriate personnel of their medical condition. They should also provide information regarding the risks of working in hazardous environments to the pregnant provider of emergency services that can be shared with her obstetrician. The policy should encompass options of non-hazardous duties, leaves of absences (for either parent-father's take paternal leave, too), discussions of continued benefits, whether or not the department will be able to accommodate additional personal protective equipment including self-contained breathing apparatus (SCBA) to adapt to her changing body, and whether or not participation in training exercises will continue, and the procedures necessary to return to full active duty after the birth of the baby. Once drafted, it would be in the best interest of the organization to have their local legal council review the prospective policy to make certain all labor laws are adhered to properly.

trained and organized fire-fighting units in history. Florian became a Christian, and was executed by the Roman Army when he refused to recant his faith and persecute other Christians. Because he was a martyred fire-fighter, he was canonized as a saint, and became the patron saint of firefighters around the world.

Today, the word “Florian” is used in Europe as a synonym for firefighter or fire department.

**NEW LAW REQUIRES  
ADDITIONAL TESTING FOR  
ALL CAREER KENTUCKY  
FIREFIGHTER CANDIDATES**

Versailles, KY – Beginning **January 1, 2013**, all career firefighter candidates will be required to undergo a physical ability test.

The candidate physical ability test (CPAT) will be designed to assess a candidates’ ability to handle the physical demands of fighting fires and shall include exercises that stimulate the most common tasks involved in fire suppression.

“Today’s firefighters have to be prepared to handle a variety of situations,” said Ronnie Day, executive director of the Kentucky Fire Commission. “This test will allow us to evaluate career firefighter candidates well before they begin recruitment training and/or on-the-job training.”


Exercises for the CPAT will include, but are not limited to: stair climbing, hose drag, equipment carry, ladder raise and extension, forcible entry, search, rescue, ceiling breach, and pull.

The Kentucky Fire Commission will charge a fee of \$125 for all out-of-state firefighter candidates participating in the CPAT. In-state participants will not be required to pay a fee.



I am willing to do this because I understand that we all make choices in life. As for myself, this is the choice and path of service I have chosen to follow. Though my job is often rewarding, it can also be unsettling. I often reflect upon the simplicity of one question, “Who am I ?” At times, I cannot provide this answer, not even for myself. So, “Who am I” to choose a profession in life that regularly shows no mercy for the preciousness of life? “Who am I” to willingly, without hesitation, invite myself into some of the most uninviting situations known to mankind? “Who am I”, so that when duty calls, may never again lay eyes on the loved ones I could leave behind? The assumed simplicity of this question is not so simple after all. Understanding “Who am I” may be difficult to answer at times. However, all I need to do is pause, think about, and remember those lives I have positively influenced and maybe even saved. All I need to do is look back on the years of service I have given to my community and realize that I have helped make the world a safer place in which to live. In my heart, I know I made a difference. “Who am I ?” I am a Firefighter !



Lessons Learned – A Tribute to John Ridge

More than any other factor, the success I've had in my fire service career and beyond is due to my first fire department assignment, to Louisville (Kentucky) Fire Department Quad Company #4, which I began on November 12, 1967. That was also the day I began a life-long education with Captain John Ridge. It was a different world then, a time of big fires and lots of them, and Captain (later to become Colonel) Ridge instilled in every company member the importance of studying past fires and applying lessons learned through pre-planning and training. And every duty day that is exactly what we did. Colonel Ridge was the finest firefighter, fire officer, teacher, and leader I have ever known. In late October 2011, he died of amyotrophic lateral sclerosis. He was 83.

Earlier in the fall, when I called his daughter-in-law to see how he was doing, she told me that he wanted to talk to me. I had no idea what to expect, as John was a realist and knew his days were short. We talked for a few hours, and he told me he'd completely pre-planned his funeral. He'd even written his own eulogy.

But that's not why he wanted to talk. He wanted me to look at a photo he thought might be of the Feeder's Supply fire in Louisville in the early 1970s, and if I'd been there. The photo was of very poor quality, though, and we couldn't tell which fire it was or if I was there. Then he asked if I remembered the Texas City fire. Like most students of our profession, I was familiar with it; it was the first time I'd read about the hazards associated with ammonium nitrate fertilizer. While we talked I contacted the NFPA librarian, Sue Marsh, to ask for help, and she soon found an article on the fire. It occurred on April 16, 1947, in Texas City, just

across the bay from Galveston. The ammonium nitrate explosion killed 468 people, injured 2,000, and damaged 1,000 buildings, resulting in property loss exceeding \$40 million. It also killed all 28 members of the Texas City Fire Department.

John explained why he wanted to discuss these two fires. Like the Texas City fire, the Feeder's Supply fire involved large amounts of ammonium nitrate fertilizer. Unlike Texas City, there were no deaths or injuries at Feeder's Supply, and the fire was confined to the building of origin. "I read about the Texas City fire in an NFPA publication in 1950, took the lessons learned and incorporated them into our pre-planning and training, and put that information to work at the Feeder's Supply fire," he told me. "NFPA never received the credit it deserved in those days, but I feel NFPA should be recognized, even 40 years after the fact, for the outstanding work it has done in helping prepare fire officers in the field."

Throughout our book, *Structural Fire Fighting*, Ben Klaene and I talk about the importance of learning from past incidents, and then pre-planning and training to apply those lessons to future incidents. For this reason, our text includes numerous case studies of past fires. Talking with John, I was once again reminded of the importance of learning from the past. I hope this brief tribute is a fitting way for me to thank the finest firefighter I have ever known, and that it accomplishes John's desire to recognize NFPA for the fine work it has done for more than 100 years.



### **Final Legislative Report for 2012 Session**

The 2012 legislative session has come and



gone and again the political problems between the Governor's office and Senate leadership caused the breakdown. Again the Governor called for another special session the week after the regular session ended. This time over the road plan and during this special session many issues other than the road fund came up with fighting along party lines and a veto by the Governor.

Firefighter issues during the regular session this year that we followed range from firefighter safety, changing taxing districts, pension, cities,

counties and appropriations just to name a few. This year I sent 14 different legislative reports, and a meeting report to try to keep everyone informed of what was going on in Frankfort, January through April. We began this year with high hopes but as with past years not many issues passed. Sometimes it is better to retain what we have gained in the past rather than losing any of the current benefits. There were a total of 786 bills introduced 220 senate bills and 566 house bills and 605 resolution introduced in total by both houses. Of these only 113 passed. That number is way down from the past and I think the reason is that the redistrict issue started the political fights in both houses. What was ironic they passed two of the first four that the Supreme Court ruled unconstitutional.

Here is a summary report of the bills that we had on our legislative report #14 and how some of them progressed during this year's session:

- HB 38 Rep. C. Rollins – An Act relating to safety inspections for official vehicles. After talking to the sponsor about the cost to volunteer fire departments. This bill did not pass.
- HB 122 Rep. Rollins – An Act relating to local ordinances concerning residential care facilities. This bill passed with our amendment attached.
- HB 189 Rep. Jimmy Lee – An Act relating to merged governments. This bill passed with our amendment attached.
- HB 193 Rep. M. Meredith – An Act relating to a tax credit for Volunteer Firefighters. We supported this bill but due to budget problems we could not get it moving. Did Not Pass.
- HB 214 Rep. S. Riggs - An Act relating to worker's compensation benefits for firefighters. This bill passed the House but did not get heard in the Senate. Did Not Pass into law.
- HB 232 Rep. Jimmy Lee – An Act relating to sheriff's collection fees for volunteer fire department membership charges or subscriber fees. This bill passed after we discussed with the members of the KFA who gain more from these collections.
- HB265 Rep. R. Rand – An Act relating to appropriation (the budget). This bill passed after long debate and many changes. The budget money we requested was in this budget and there was

an additional \$7.3 million transferred each year from the fire commission to the General Fund.

- HB 300 Rep. M. Cherry – An Act relating to retirement and declaring an emergency. This bill passed. This bill was clean up language for the retirement system. The only thing changed for firefighters was that the retirement COLA was suspended for the next two years.

- HB 324 Rep. R. Henderson – An Act relating to payments for firefighters permanently and totally disabled in the line of duty. This bill passed after trying to pass it for the last 7 years! The only change we made from the past 7 years was change CPI to increase by \$100.00 to a total of \$300.00. Praise the Lord!

- HB 326 Rep. R. Nelson – An Act relating to firefighters only passed the House Committee did not pass into law.

- HB 338 Rep. T. Thompson – An Act relating to delaying the effective date of insurance premium surcharge increases. This bill passed after discussion from our legislation committee.

- HB 423 Rep. D. Floyd – An Act relating fire protection districts and declaring an emergency. We did amend this bill and supported it. This bill did not pass.

- HB 461 Rep B. Yonts –An Act relating to fire protection sprinklers systems design and installation. This bill passed.

- HB 471 Rep. J. Gooch Jr. – An Act relating to the Kentucky firefighters foundation employer reimbursement fund and making an appropriation therefor. We worked against this bill because it would have taken funds from our programs. This bill did not pass.

- HB 502 Rep. T. Thompson – An Act relating to pension plans for second class cities. This bill passed.

- SB 55 - Senator Westwood - An Act relating to Interstate Mutual Aid Agreements. This bill passed with our amendment.

SB 91 Senator E. Harris – AN Act relating to ambulance taxing districts. This bill passed

There were many hours spent in Frankfort during this year's legislative session and I must thank those who spent the time to walk the halls for the firefighters of this Commonwealth;

**THE NATIONAL FIRE PROTECTION ASSOCIATION LAUNCHES CAMPAIGN TO RECRUIT CODE ENFORCERS TO TECHNICAL COMMITTEES**

Quincy, MA- The National Fire Protection Association (NFPA) recently launched a recruitment campaign to increase the number of code enforcers participating on the NFPA's Technical Committees. NFPA has more than 200 technical committees, which create and revise codes and standards that protect people and property. NFPA seeks to have code enforcers represent at least 20 percent of the overall Technical Committee membership by 2013.

“One of the greatest strengths of the NFPA standards-development process is broad participation. We work extremely hard to ensure we have a balance of interests on these committees.” said James Shannon, president of NFPA. “ We need code enforcers because they have particular knowledge and experience on how our codes and standards are applied in the field. We need them to provide their expertise to the important work that is being done by our Technical Committees in order to advance our safety mission.”

Recent cuts in municipal budgets, including elimination of travel expenses for public employees, have made it harder for code enforcers to participate in technical committee meetings. In response to this concern, the NFPA created special funding to subsidize 80 percent of travel and lodging expenses that may come when code enforcers participate in technical committee meetings. The assistance with these expenses is available to code enforcers who are public employees or part of the volunteer fire service.

“We created this special funding as part of our commitment to make the NFPA Technical Committees as accessible as possible to code enforcers whose participation is needed to ensure that we have a balance of voices in the process,” said Shannon.

Recently, the NFPA conducted a survey of current Technical Committee members and found a high level of satisfaction in participants. For code enforcers, participating in NFPA Technical Committees can provide an opportunity to help im-


prove safety, a chance to network with other code professionals and a way to learn more from industry experts. In return, NFPA technical committee members are asked to participate in approximately 10 meeting days over a 3-5 year period sharing their expertise and individual perspective.
