When long time instructor and friend Charles (Sparky) Sparks died in the Line of Duty on July 8<sup>th</sup> 2011, Charlie Shaw and the Area 14 Staff wanted to pay tribute to him, their staff and all emergency service personnel across the Commonwealth of Kentucky. So it was decided to dedicate one quarter acre on the east end of the Area 14 State Fire Rescue campus to build a Reflection Park.

Webster’s on-line dictionary gives 9 possible definitions of “Reflection”. Definition number 6 defines reflection as **“a thought, idea, or opinion formed or a remark made as a result of meditation”**. When I spent time reflecting on the life of my friend Sparky the memory was fun filled and brimming with life. I recalled the many hot June State Fire School days when SFRT and The State Fire Marshal’s Office would conduct Flammable Liquids and Gasses classes which he truly loved to participate in.

When I talked to Charlie Shaw early in the development of the park his plans were to take about a month for completion. Three months and many painstaking details later the Reflection Park was dedicated on October 6, 2011.

The park when completed will see the addition of a Gazebo and a Picnic area. Please take the time in the not too distant future and visit the park. It is an appropriate and beautiful tribute to Sparky and all emergency responders. It is located on the campus of State Fire Rescue Training Area 14, 385 Old Greensburg Road, Campbellsville Kentucky 42718. It’s not too late for you to donate to the park. 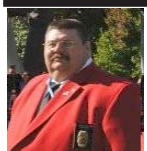

Department membership reminders will have mailed in November. During 2011, the KFA began receiving a portion of Firefighter vehicle license plate sales through the Kentucky Transportation Cabinet. The KFA encourages all firefighters to purchase the Kentucky Firefighter license plate when you register your personal auto or truck. This is done through the county clerk's office when you re-tag your vehicle. I am sorry to say that firefighter plates are not yet available for

motorcycles, but it is on the agenda of the KFA to see that option become available soon. It takes submission of a petition-like document with enough signatures to meet statutory and regulatory requirements to have the plates produced. If you are interested, watch for opportunities at conferences and fire schools to sign up asking the transportation cabinet to begin producing Firefighter plates for motorcycles.

## Dixie Firefighters' Association

Would your vote make a difference in who leads this

organizations, the point was made that, while we understood the current financial climate, we expected current fire grant and SAFER programs to be closely considered.

A good bit of time was spent reviewing the financial position of the NVFC in light of current financial conditions. At this time the organization is financially sound and will be able to complete current projects. Corporate support for the NVFC continues to grow. A budget of \$2,351,000.00 was approved.

The NVFC committees have been very busy in attending NFPA meetings. This is something our state membership wants us to do as they feel it protects volunteers from unnecessary and costly standards. A top NFPA representative always attends our meetings which gives us an opportunity to have direct dialogue with them.

The NVFC has been working with NIOSH to help them connect more easily with volunteer departments.

The Strategic Plan draft that was approved by the Executive Committee was presented to the state directors and alternates. The NVFC plans to complete a three year plan rather than the five year plan we have developed in the past.

The Heart Healthy program was taken to eleven shows this past year. I had an opportunity to attend two of those and found them quite interesting. If interested, contact the NVFC office.

The National Junior Firefighter Program is totally funded by corporate sponsors. If you have a program or are interested in starting a program, check the NVFC site or call the office.

A Firefighter Arson Toolkit is being developed to help fire departments deal with any firefighter arson case.

We are again working with Georgia Pacific to promote the Bucket Brigade. If you have a Georgia Pacific facility in your area, contact them about this project.

Many webinars and training platforms have been held by the NVFC. Check the web site for information on programs and dates.

Interest for foreign firefighter groups continues to increase. Currently we have developed relationships with Japan, Greece, Australia, South American Bombaros, and others. They are very interested in the material we have developed.

Written testing information is available on the Ky IFSAC testing web site at <http://www.kyffcert.com>. Tests are given at the system office usually on the third Monday of the month. Each time you take the written test you must pay a \$15.00 charge. Contact Duane Suttles for more information about written test location and dates at 888-301-2946. REMINDER: Candidates must be at least 18 years of age and be a member of a Kentucky FD or a full-time student of Fire Science at EKU or KCTCS to be eligible for firefighter testing. Candidates must bring state issued drivers license or ID card to skills testing site for positive identification and verification of age eligibility. Candidates under 18, may complete any of the written exams, and may certify to Haz Mat Awareness only. All Certifications are based on the Professional Qualification standards set forth by the NFPA for Firefighters, except Haz Mat, which is a Job Performance standard. Our accreditation is through the International Fire Service Accreditation Congress (IFSAC).

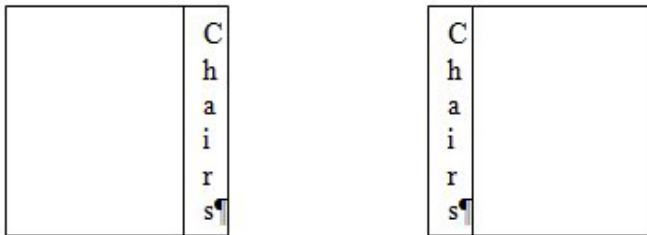

## A Code Moment...

It's finally here! The holiday season with all the trimmings including turkey, ham, and dressing; as well as combustible decorations, burning candles everywhere and overcrowded rooms. Let's take a look at some assembly basics and the problems that holiday celebrations can bring. Remember that table and chair seating in assembly areas is limited to 15 sq. ft. per person with a minimum of 74" between the table edges when people are seated back to back. This is a dramatic change for many occupants who are used to having just enough room to squeeze between seated occupants trying to get to a table.

19" -- 36" or 44" -- 19"



In this example, there are 19" permitted for each seated occupant with a 36" minimum aisle in between (up to 50 occupants, then use 44"). Booths and tables along walls are calculated differently; as are tables that don't abut an aisle and have seating on only one side facing a stage or speaker podium. Refer to the 2006, NFPA 101 *Life Safety Code*®, chapter 13.2 for further guidance.

Moving on to what people do with decorations, the primary hazard is, of course, combustibility. For this we can reference the other primary document in Kentucky, NFPA 1 *Uniform Fire Code*® (2006). It reads in chapter 10.14.2: "In any occupancy, limited quantities of combustible vegetation shall be permitted where the AHJ determines that adequate safeguards are provided based on the quantity and nature of the combustible vegetation." For example, "live cut" Christmas trees are **not** permitted in assembly, board and care, educational, dormitories, detection and correctional facilities, and hotel occupancy types. Some "live cut" greenery may be permitted for decoration but the local authority has to determine the appropriateness and may balance it on the presence of a sprinkler suppression system, limited quantity, etc. Paper and cloth decorations must also be limited and should be flame retardant or properly treated.

The use of candles is also specifically limited. "Securely supported altar candles" are permitted for ceremonial or religious purposes if the location is well clear of combustible materials. Similarly, they can be used on stages and platforms where part of a performance; and most commonly, can be used on tables when they are "securely supported on non-combustible bases and the candle flame is protected" (NFPA 1, 2006 edition, chapter 20.1.4.3).

Every Kentucky firefighter should be well aware of risk of holiday excess in these areas with the history of the Beverly Hills Supper Club fire on Mother's Day, 1977 (165 dead) in northern KY. Similar over crowding and decoration conditions existed at the Coconut Grove Nightclub in Boston, Massachusetts where a fire on November 28, 1942 killed 492 people.

But a Christmas Holiday tragedy in the small, rural town of Babb's Switch, Oklahoma on Christmas Eve of 1924 relates to all sizes of fire department. This fire killed 35 community members in a small one-room schoolhouse and was decoration related, with candles on a Christmas tree, overcrowding and limited exits as key factors. Most firefighters reading this have likely been uncomfortable in an assembly area before, because of something they knew that wasn't right, or safe. My question is - what are you going to do about it in your own community? The history of assembly fires often reveals that if a fire department is going to save lives in this type of occupancy, it's done through prevention and inspection. Suppression activities are often just too late.

Happy holidays, I hope the calls are few and not serious, and that you get to spend the season with your families uninterrupted!

The new EMS/R section continues to develop. The process has begun to develop the Section’s own Strategic Plan. The intent is to give ownership of the Section to the Section membership.

The NVFC passed a resolution to support the National Fallen Firefighter Foundation (NFFF) safety initiatives and the IAFC-SHS Rules of engagement. Take the time to look into these important programs.

A resolution was passed to endorse the Transportation Safety Advisory Group Next Generation 911 “Who’s Next” Report and that the NVFC engage a stakeholder through the Radio/Wireless Committee. The EMS/R Section also supported this resolution.

We will be improving our selection process for AFG/SAFER/FP&S Peer reviewers.

As you can see these are busy meetings. I got around to as many individual meetings as I could. I appreciate the opportunity to represent Kentucky’s firefighters at these meetings. The KFA has made a major financial commitment to allow Bryant Stiles and me to continue our involvement with the NVFC. We wish to thank you and the KFA executive board for your continued support.



### Recertification Audits to begin in January

The Kentucky Board of EMS would like to remind all responders who recertify prior to December 31, 2011 that the audit process will begin in January 2012. The audit will include all levels of certification including that of instructor. If you are selected for an audit, you will be notified by the KBEMS office. You will then have 15 business days to return copies of the continuing education documentation required by your particular licensure level. Information on renewal requirements for First Responder, EMT and Paramedic levels can be found at [KBEMS Renewal Requirements](#). The requirements to renew as an instructor are as follows:

202 KAR 7:601. Section 15. Renewal of EMS Instructor Certification. (1) A person certified by the board as an EMS instructor shall be eligible to renew the EMS instructor certification if the person:

(a) Maintains state certification or licensure as a provider, which as a minimum is at the level at which they are certified to instruct;

(b) Presents written evidence of completion of

current HIV/AIDS training and education required by KRS 311A.110;

(c) During the preceding two (2) years, obtains a minimum of fifty-two (52) contact hours, providing documented evidence of completion of each hour, in the following categories:

1. A minimum of four (4) contact hours on topics related to methods of instruction (MOI);

2. Conducts a minimum of twenty-four (24) hours, or one (1) hour per each full month of certification if a certificate has been in effect for less than twenty-four (24) months, of instruction on at least three (3) different topics that are within the training and education requirements and the scope of practice for a level at which they are authorized to instruct; and

3. Presents evidence of participatory involvement in a minimum of twenty-four (24) hours, or one (1) hour per each full month of certification if a certificate has been in effect for less than twenty-four (24) months, of patient care experience with an ambulance service or other organization having an EMS mission, fire department, rescue squad, mining or other industrial health setting providing emergency medical services to their employees or members of the general public in any of the following roles of participation:

a. Actual patient emergency responses;

b. Agency quality assurance activities related to EMS; or

c. Enrolled as a participant or instructor for continuing education or agency-specific in-service training and education sponsored by the agency. 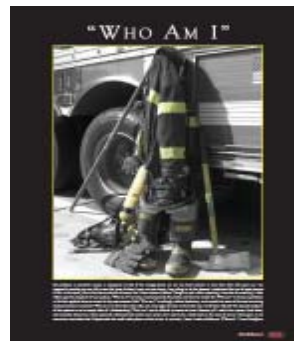

### Legislative Report



Here we go again with another full legislation session and many issues to discuss. The 2012 Kentucky General Assembly will have many issues that are important issues to try to address. And with the revenue outlook so bleak there are many funding items could be cut.

This year at the KFA conference in Owensboro the delegates passed the following legislative resolutions;

- 1. Resolution #1** encourages the Kentucky Fire Commission to review the possibilities of creating a firefighter support position within the ranks of volunteer firefighter.
- 2. Resolution #4** form a working group consisting of representative members of all groups working toward the adoption of an alternative assessment tool for student seeking certification as First Responders or EMTs in the State of Kentucky, such tool being offered in addition to the National registry examination and not as a replacement. If this alternative assessment is not demonstrated it is understood that legislation to mandate adoption of an alternative will be introduced.
- 3. Resolution #5** supports the efforts of Kentucky EMA to pass legislation that would clarify issues relating to mutual aid assistance by emergency response agencies crossing state lines.

In addition to these issues other fire organizations will be bringing other issues that we will be discussing. On Monday November the 14<sup>th</sup> we are having a meeting to discuss the issues that all groups might bring up during this year's session. This meeting is being held in the office of the State Fire Marshal and we will hope we can all work together on all issues, as in the past these meetings have assisted in the passage of some important fire service legislation, we know we might not agree on all issues but we do on about 95% and can help each other.

As in the past we go into this session with high hopes for the fire service legislation agenda but as this session begins we understand it is our responsibility to try to maintain what we have gained over the years. This could mean to maintain what we have we might not pass anything but the most important issue is that we be in Frankfort to represent the fire service to the best of our ability and maintain or

improve over what we have gained for the fire service.

We will be watching many areas for legislative changes from many other groups; Cities, Counties and State Agencies just to name a few. Issues like Workers Compensation, Pension, Labor, Cities, Counties, State Agencies, Public Safety, Special Districts, Firefighter and Fire Department, Hazardous Materials, Emergency medical, federal laws and Regulations. These are just a few of the items that we watch.

The members of the fire service who in the past have been attending the legislative sessions on behalf of the fire service are: Gerald Stewart, Bruce Roberts, Chris Barlet, Jack Reckner, Craig Willman, Mark Blankenship, Ronnie Day and myself. We are there most days if you have questions and need to contact anyone in Frankfort please make contact with one of these members for assistance on issues before the legislature.

We will be sending out reports each week on issues that affect the fire service. If you are anyone in your department want to be on our email address and are not receiving these notices please contact me and I will add you to the list during the session and all information that we are sending.

### VOLUNTEER FIREFIGHTER RECRUITMENT AND RETENTION

The safety of citizens and fellow firefighters in many communities throughout the Commonwealth of Kentucky depends on having capable, dedicated volunteer firefighters. Over the past decade nationally there has become difficulty in recruiting and retaining volunteer firefighters. A majority of our Kentucky volunteer fire departments are following this national trend of difficulty in recruiting and retaining volunteer firefighters.

The Kentucky Fire Commission / State Fire Rescue Training has embarked on a three year volunteer firefighter recruitment and retention program, funded through a three year SAFER grant. This grant provides for a Recruitment and Retention Coordinator who will be 100% focused on this issue.

The Kentucky Fire Commission / State Fire Rescue Training have long been dedicated to supporting our volunteer fire service. This includes providing workers compensation coverage for each volunteer firefighter and 20 hours of training delivered direct into each fire department in the Commonwealth.

The new, federally funded, recruitment position will provide an individual who has a single focus of improving volunteer firefighter recruitment and retention. This focus will include statewide research and programs as well as local fire department assistance when fire departments request help with their specific recruitment and / or retention needs.

The Recruitment and Retention Coordinator will work closely with the Fire Commission / Fire Rescue Training's History and Recruitment Mobile Center as the concept of this facility is to build upon the history of Kentucky's fire service as we recruit the next generation of firefighters.

Recruiting volunteer firefighters can always benefit career fire departments as many volunteers gain a love for the fire service and prove their selves on the fire ground and choose to make the fire service their full time career.

After an extensive search for a Recruitment and Retention Coordinator, Pat Thompson has been selected and is already responding to fire department requests for recruitment and retention assistance. Pat brings to the position extensive experience working with the volunteer fire service at the local, regional and state levels. Pat is Chief of Sorgho Volunteer Fire Department in Daviess County, an all volunteer fire department. He has been Treasurer of the Green River Firefighters Association for years where he was instrumental in the development of two volunteer firefighter recruitment videos. Pat has been active on the state level including serving as a member of the Kentucky Fire Commission.
